A BILL

FOR AN ACT relating to medicaid; to amend sections 43-2511, 43-2513, 1 43-2515, 79-1119, and 79-1145, Reissue Revised Statutes 2 of Nebraska, section 79-1018.01, Revised Statutes Cumulative Supplement, 2012, and section 68-911, Revised 4 Statutes Supplement, 2013; to change provisions relating 5 to the statewide billing system and funding for services 6 7 under the Early Intervention Act; to provide for a state plan amendment under the Medical Assistance Act for 8 certain services provided by school districts; to change 9 local system formula resources under the Tax Equity and 10 Educational Opportunities Support Act; to change the 11 amount of appropriations for and requirements 12 reimbursement under the Special Education Act; to 13 14 harmonize provisions; and to repeal the original 15 sections.

16 Be it enacted by the people of the State of Nebraska,

Section 1. Section 43-2511, Reissue Revised Statutes of 1 2 Nebraska, is amended to read: 3 43-2511 There is hereby established a statewide billing 4 system for accessing federal medicaid funds for special education and 5 related services provided by school districts. The system shall apply to all students verified with disabilities from date of diagnosis to 6 7 twenty-one years of age as allowed under the federal Medicare 8 Catastrophic Coverage Act of 1988. The system shall be developed, 9 implemented, and administered jointly by the Department of Health and 10 Human Services and the State Department of Education. On or before October 1, 2015, the Department of Health and Human Services and the 11 12 State Department of Education shall jointly revise the statewide 13 billing system to streamline and simplify the claims process, to 14 update reimbursement rates, and to incorporate services included in 15 the state plan amendment submitted pursuant to subsection (4) of 16 section 68-911. After the reimbursement rates have been updated pursuant to this section, such rates shall be reviewed at least once 17 every five years. School districts, educational service units, or 18 approved cooperatives providing special education and related 19 20 services shall be required to participate in the statewide billing 21 system. It is the intent of this section that Eleven and fifty-four 22 hundredths percent of federal medicaid funds received by school 23 districts pursuant to such billing system shall be considered reimbursement for the costs to school districts associated with the 24

implementation and administration of such a system, and such costs

- 21 prior to 2015-16, excess cost means the difference between the total
- 22 cost of the special education program excluding residential care and
- 23 the number of students in the special education program multiplied by
- 24 the adjusted average per pupil cost of the preceding year for the
- 25 school district of residence of each child. For aid distributed in

1 school fiscal year 2015-16 and each school fiscal year thereafter,

- 2 excess cost means the difference between the total cost of the
- 3 special education program excluding residential care minus federal
- 4 medicaid funds received pursuant to section 43-2511 for services to
- 5 school-age children excluding amounts designated as reimbursement for
- 6 costs associated with the implementation and administration of the
- 7 billing system pursuant to section 43-2511 and minus the product of
- 8 the number of students in the special education program multiplied by
- 9 the adjusted average per pupil cost of the preceding year for the
- 10 school district of residence of each child.

- 12 Nebraska, is amended to read:
- 79-1145 (1) For each fiscal year prior to fiscal year
- 14 2014-15, the aggregate amount of General Funds appropriated for
- 15 special education programs and support services pursuant to sections
- 16 79-1129, 79-1132, and 79-1144 shall not exceed the aggregate amount
- 17 of General Funds appropriated pursuant to such sections for the
- 18 previous fiscal year, multiplied by one plus a rate of increased by
- 19 five percent.
- 20 (2) For fiscal year 2014-15 and each fiscal year
- 21 thereafter, the aggregate amount of General Funds appropriated for
- 22 special education programs and support services pursuant to sections
