A BILL

1 FOR AN ACT relating to elections; to amend section 32-554, Reissue
2 Revised Statutes of Nebraska, and section 32-101, Revised
3 Statutes Cumulative Supplement, 2012; to require the
4 Secretary of State to develop and publish guidelines for
5 election workers; to change provisions regarding
6 political subdivisions; to harmonize provisions; and to
7 repeal the original sections.
8 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 32-101, Revised Statutes Cumulative
2 Supplement, 2012, is amended to read:

3 32-101 Sections 32-101 to 32-1551 and section 2 of this
4 act shall be known and may be cited as the Election Act.

5 Sec. 2. The Secretary of State shall develop and publish
6 guidelines for election workers appointed pursuant to sections 32-220
7 to 32-240. The guidelines shall include provisions for the conduct of
8 election workers with regard to the conduct of elections on election
9 day. The guidelines may cover other conduct with regard to election
10 workers and, in that regard, shall take into account variations in
11 counties with regards to election workers appointed under sections
12 32-221 to 32-228 which apply to counties which have an election
13 commissioner as provided in section 32-207 or 32-211 and election
14 workers appointed under sections 32-230 to 32-240 which apply to
15 counties which do not have an election commissioner. The guidelines
16 shall be instructional in nature and shall not be construed to bind
17 election commissioners or county clerks.

18 Sec. 3. Section 32-554, Reissue Revised Statutes of
19 Nebraska, is amended to read:

20 32-554 (1)(a) Any city not under a home rule charter,
21 village, county, or school district nominating and electing members
22 to its governing board at large may, either by majority vote of the
23 governing body or by petition of registered voters pursuant to
24 subsection (2) of this section, at a general election submit, at a
25 general election, the question of nominating and electing members to

1 its governing board by district or ward.

2 (b) Any city not under a home rule charter, village,
3 county having not more than three hundred thousand inhabitants, or
4 school district nominating and electing members to its governing
5 board by district or ward may, either by majority vote of the
6 governing body or by petition of registered voters pursuant to
7 subsection (2) of this section, at a general election submit, at a
8 general election, the question of nominating and electing members to
9 its governing board at large.

10 (c) Any city of the first class, except a city having
11 adopted the commissioner or city manager plan of government,
12 nominating and electing members to its governing body by ward may,
13 either by ordinance by majority vote of the governing body or by
14 petition of registered voters pursuant to subsection (2) of this
15 section, at a general election submit, at a general election, the
16 question of nominating and electing some of the members to its
17 governing body by ward and some at large. ~~either by ordinance by a~~
18 ~~vote of a majority of the members of the governing body or by~~
19 ~~petition of the registered voters of the city.~~ No more than three
20 four members of the city council may be elected on an at-large basis,
21 and at least four members of the city council shall be elected by
22 ward. The ordinance of the governing body or petition shall specify
23 the number of at-large members to be elected. At the first election
24 in which one or more at-large members are to be elected to the city
25 council, the members shall be elected to serve for initial terms of

1 office of the following lengths: (i) If one at-large member is to be
2 elected, he or she shall serve for a four-year term; (ii) ~~If~~if two
3 at-large members are to be elected, the candidate receiving the
4 highest number of votes shall be elected to serve for a four-year
5 term and the other elected member shall be elected to serve for a
6 two-year term; ~~and~~ (iii) ~~If~~if three at-large members are to be
7 elected, the two candidates receiving the highest number of votes
8 shall be elected to serve for four-year terms and the other elected
9 member shall be elected to serve for a two-year term; and (iv) if
10 four at-large members are to be elected, the two candidates receiving
11 the highest number of votes shall be elected to serve for four-year
12 terms and the other elected members shall be elected to serve for
13 two-year terms. Following the initial term of office, all at-large
14 council members shall be elected to serve for four-year terms. No
15 candidate may file as both an at-large candidate and a candidate by
16 ward at the same election.

17 (2) Petitions for submission of the question shall be
18 signed by registered voters of the city, village, county, or school
19 district desiring to change the procedures for electing the governing
20 board of the city, village, county, or school district. The petition
21 or petitions shall be signed by registered voters equal in number to
22 twenty-five percent of the votes cast for the person receiving the
23 highest number of votes in the city, village, county, or school
24 district at the preceding general election for electing the last
25 member or members to its governing board. Each sheet of the petition

1 shall have printed the full and correct copy of the question as it
2 will appear on the official ballot. The petitions shall be filed with
3 the county clerk or election commissioner not less than seventy days
4 prior to the date of the general election, and no signatures shall be
5 added or removed from the petitions after they have been so filed.
6 Petitions shall be verified as provided in section 32-631. If the
7 petition or petitions are found to contain the required number of
8 valid signatures, the county clerk or election commissioner shall
9 place the question on a separate ballot to be issued to the
10 registered voters of the city, village, county, or school district
11 entitled to vote on the question.

12 (3)(a) Any city, village, county, or school district
13 voting to change from nominating and electing the members of its
14 governing board by district or ward to nominating and electing some
15 or all of such members at large shall notify the public and instruct
16 the filing officer to accept the appropriate filings on an at-large
17 basis. Candidates to be elected at large shall be nominated and
18 elected on an at-large basis at the next primary and general election
19 following submission of the question.

20 (b) Any city, village, county, or school district voting
21 to change from nominating and electing the members of its governing
22 board at large to nominating and electing by district or ward shall
23 notify the public and instruct the filing officer to accept all
24 filings by district or ward. Candidates shall be nominated and
25 elected by district or ward at the next primary and general election

1 following submission of the question. When district or ward elections
2 have been approved by the majority of the electorate, the governing
3 board of any city, village, county, or school district approving such
4 question shall establish districts substantially equal in population
5 as determined by the most recent federal decennial census except as
6 provided in subsection (2) of section 32-553.

7 (4) Except as provided in section 14-201, each city not
8 under a home rule charter, village, county, and school district which
9 votes to nominate and elect members to its governing board by
10 district or ward shall establish districts or wards so that
11 approximately one-half of the members of its governing board may be
12 nominated and elected from districts or wards at each election.
13 Districts or wards shall be created not later than October 1 in the
14 year following the general election at which the question was voted
15 upon. If the governing board fails to draw district boundaries by
16 October 1, the procedures set forth in section 32-555 shall be
17 followed.

18 Sec. 4. Original section 32-554, Reissue Revised Statutes
19 of Nebraska, and section 32-101, Revised Statutes Cumulative
20 Supplement, 2012, are repealed.
