#### A BILL

FOR AN ACT relating to elections; to amend sections 32-204, 32-308, 32-309, 32-311, 32-312.05, 32-315, 32-321, 32-323, 2 32-325, 32-902, and 60-484.02, Reissue Revised Statutes of Nebraska, sections 32-312, 32-915, and 32-1002, Revised Statutes Cumulative Supplement, 2012, sections 32-101 and 60-484, Revised Statutes Supplement, 7 2013; to provide for voter registration on the Secretary of State's web site; to provide for electronic 8 9 transmission of certain voter registration applications; to provide for use of records of the Department of Motor 10 Vehicles for purposes of voter registration; to harmonize 11 provisions; and to repeal the original sections. 12

13 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 32-101, Revised Statutes Supplement,

- 2 2013, is amended to read:
- 3 32-101 Sections 32-101 to 32-1551 <u>and section 3 of this</u>
- 4 <u>act</u>shall be known and may be cited as the Election Act.
- 5 Sec. 2. Section 32-204, Reissue Revised Statutes of
- 6 Nebraska, is amended to read:
- 7 32-204 The Election Administration Fund is hereby
- 8 created. The fund shall consist of federal funds, state funds, gifts,
- 9 and grants appropriated for the administration of elections. The
- 10 Secretary of State shall use the fund for voting systems, provisional
- 11 voting, computerized statewide voter registration lists, voter
- 12 registration, by mail, training or informational materials related to
- 13 elections, and any other costs related to elections. Any money in the
- 14 fund available for investment shall be invested by the state
- 15 investment officer pursuant to the Nebraska Capital Expansion Act and
- 16 the Nebraska State Funds Investment Act. The State Treasurer shall
- 17 transfer any money in the Voter Registration Cash Fund on February
- 18 21, 2003, to the Election Administration Fund.
- 19 Sec. 3. (1) The Secretary of State in conjunction with
- 20 <u>the Department of Motor Vehicles shall, on or before July 1, 2015,</u>
- 21 develop and implement a registration application process which may be
- 22 <u>used statewide to register to vote and update voter registration</u>
- 23 records electronically using the Secretary of State's web site. An
- 24 applicant who has a valid Nebraska motor vehicle operator's license
- 25 or state identification card may use the application process to

1 register to vote or to update his or her voter registration record

- 2 with changes in his or her personal information or other information
- 3 related to his or her eligibility to vote. For each electronic
- 4 application, the Secretary of State shall obtain a copy of the
- 5 electronic representation of the applicant's signature from the
- 6 Department of Motor Vehicles' records of his or her motor vehicle
- 7 operator's license or state identification card for purposes of voter
- 8 registration.
- 9 (2) The application shall contain substantially all the
- 10 <u>information provided in section 32-312 and the following</u>
- 11 informational statements:
- 12 <u>(a) An applicant who submits this application</u>
- 13 electronically is affirming that the information in the application
- 14 is true. Any applicant who submits this application electronically
- 15 knowing that any of the information in the application is false shall
- 16 be quilty of a Class IV felony under section 32-1502 of the statutes
- 17 of Nebraska. The penalty for a Class IV felony is up to five years
- 18 imprisonment, a fine of up to ten thousand dollars, or both;
- 19 (b) An applicant who submits this application
- 20 electronically is agreeing to the use of his or her signature from
- 21 the Department of Motor Vehicles' records of his or her motor vehicle
- 22 operator's license or state identification card for purposes of voter
- 23 registration;
- 24 (c) To vote at the polling place on election day, the
- 25 completed application must be submitted on or before the third Friday

- 1 <u>before the election; and</u>
- 2 (d) The election commissioner or county clerk will, upon
- 3 receipt of the application for registration, send an acknowledgment
- 4 of registration to the applicant indicating whether the application
- 5 is proper or not.
- 6 Sec. 4. Section 32-308, Reissue Revised Statutes of
- 7 Nebraska, is amended to read:
- 8 32-308 (1) The Secretary of State and the Director of
- 9 Motor Vehicles shall enter into an agreement to match information in
- 10 the computerized statewide voter registration list with information
- 11 in the data base of the Department of Motor Vehicles to the extent
- 12 required to enable each such official to verify the accuracy of the
- 13 information provided on applications for voter registration. The
- 14 Director of Motor Vehicles shall enter into an agreement with the
- 15 Commissioner of Social Security under section 205(r)(8) of the
- 16 federal Social Security Act, 42 U.S.C. 405(r)(8), as such section
- 17 existed on April 17, 2003, for purposes of the Election Act.
- 18 (2) The Department of Motor Vehicles, with the assistance
- 19 of the Secretary of State, shall prescribe a voter registration
- 20 application which may be used to register to vote or change his or
- 21 her address for voting purposes at the same time an elector applies
- 22 for an original or renewal motor vehicle operator's license, an
- 23 original or renewal state identification card, or a replacement or
- 24 duplicate thereof. The voter registration application shall contain
- 25 the information required pursuant to section 32-312 and shall be

1 designed so that it does not require the duplication of information 2 in the application for the motor vehicle operator's license or state 3 identification card, except that it may require a second signature of 4 the applicant. The department and the Secretary of State shall make 5 the voter registration application available to the county treasurer, 6 the license examiners of the department, and any other person who 7 issues operators' licenses or state identification cards. any person 8 applying for an operator's license or state identification card. The 9 application shall be completed at the office of the county treasurer 10 or-department by the close of business on the third Friday preceding any election to be registered to vote at such election. A 11 12 registration application received after the deadline shall not be 13 processed by the election commissioner or county clerk until after 14 the election. 15 (3) The Department of Motor Vehicles, in conjunction with 16 the Secretary of State, shall develop a process to electronically 17 transmit voter registration application information received under 18 subsection (2) of this section to the election commissioner or county clerk of the county in which the applicant resides within the time 19 20 limits prescribed in subsection (4) of this section. The Director of 21 Motor Vehicles shall designate an implementation date for the process 22 which shall be on or before January 1, 2016. 23 (4) The voter registration application information shall be transmitted to the election commissioner or county clerk of the 24 county in which the applicant resides not later than ten days after 25

receipt, except that if the voter registration application 1 information is received within five days prior to the third Friday 2 3 preceding any election, it shall be transmitted not later than five 4 days after its original submission. Any information on whether an 5 applicant registers or declines to register and the location of the office at which he or she registers shall be confidential and shall 6 7 only be used for voter registration purposes. 8 (5) For each voter registration application for which 9 information is transmitted electronically pursuant to this section, 10 the Secretary of State shall obtain a copy of the electronic 11 representation of the applicant's signature from the Department of 12 Motor Vehicles' records of his or her motor vehicle operator's 13 license or state identification card for purposes of voter registration. Each voter registration application electronically 14 15 transmitted under this section shall include information provided by 16 the applicant that includes whether the applicant is a citizen of the 17 United States, whether the applicant is of sufficient age to register to vote, the applicant's residence address, the applicant's postal 18 19 address if different from the residence address, the date of birth of 20 the applicant, the party affiliation of the applicant or an 21 indication that the applicant is not affiliated with any political 22 party, the applicant's motor vehicle operator's license number, the applicant's previous registration location by city, county, or state, 23 24 if applicable, and the applicant's signature.

(3) (6) State agency personnel and county treasurers

6 32-309 Upon receipt of a completed voter registration application under subsection (2) of section 32-308, a county 7 8 treasurer, a license examiner of the Department of Motor Vehicles, and any other person who issues motor vehicle operators' licenses or 9 state identification cards shall, until the implementation date 10 11 designated by the Director of Motor Vehicles pursuant to subsection 12 (3) of section 32-308, deliver the completed voter registration 13 application to the election commissioner or county clerk of the 14 county in which the county treasurer, license examiner, or other 15 person is located not later than ten days after receipt by the county treasurer, license examiner, or other person, except that if the 16 voter registration application is received within five days prior to 17 the third Friday preceding any election, it shall be delivered not 18 later than five days after its original filing date. - 4 address is private, and such designation shall preclude the listing

- 6 DRIVER'S LICENSE NUMBER OR LAST FOUR DIGITS OF SOCIAL
- 7 SECURITY NUMBER-if the applicant has a Nebraska driver's license, the
- 8 license number, and if the applicant does not have a Nebraska
- 9 driver's license, the last four digits of the applicant's social
- 10 security number.
- 11 DATE OF APPLICATION FOR REGISTRATION—the month, day, and
- 12 year when the applicant presented himself or herself for
- 13 registration, or when the applicant completed and signed the
- 14 registration application if the application was submitted by mail or
- 15 delivered to the election official by the applicant's personal
- 16 messenger or personal agent, or when the completed application was
- 17 submitted if the registration application was completed pursuant to
- 18 section 3 of this act.
- 19 PLACE OF BIRTH—show the state, country, kingdom, empire,
- 20 or dominion where the applicant was born.
- 21 DATE OF BIRTH—show the date of the applicant's birth. The
- 22 applicant shall be at least eighteen years of age or attain eighteen
- 23 years of age on or before the first Tuesday after the first Monday in
- 24 November to have the right to register and vote in any election in
- 25 the present calendar year.

1 REGISTRATION TAKEN BY-show the signature of the

- 2 authorized official or staff member accepting the application
- 3 pursuant to section 32-309 or 32-310 or at least one of the deputy
- 4 registrars taking the application pursuant to section 32-306, if
- 5 applicable.
- 6 PARTY AFFILIATION—show the party affiliation of the
- 7 applicant as Democrat, Republican, or Other ..... or show no party
- 8 affiliation as Nonpartisan. (Note: If you wish to vote in both
- 9 partisan and nonpartisan primary elections for state and local
- 10 offices, you must indicate a political party affiliation on the
- 11 registration application. If you register without a political party
- 12 affiliation (nonpartisan), you will receive only the nonpartisan
- 13 ballots for state and local offices at primary elections. If you
- 14 register without a political party affiliation, you may vote in
- partisan primary elections for congressional offices.)
- 16 OTHER—information the Secretary of State determines will
- 17 assist in the proper and accurate registration of the voter.

- 7 any of the information in the application is false shall be guilty of
- 8 a Class IV felony under section 32-1502 of the statutes of Nebraska.
- 9 The penalty for a Class IV felony is up to five years imprisonment, a
- 10 fine of up to ten thousand dollars, or both.
- 11 APPLICANT'S SIGNATURE—require the applicant to affix his
- 12 or her signature to the application.
- 13 Sec. 8. Section 32-312.05, Reissue Revised Statutes of
- 14 Nebraska, is amended to read:
- 15 32-312.05 The date that a person's voter registration
- 16 record or an update of his or her voter registration record becomes
- 17 effective is the date the person presented himself or herself in

- Sec. 10. Section 32-321, Reissue Revised Statutes of Nebraska, is amended to read:
- 12 32-321 (1) Any elector may request a voter registration 13 application from the office of the Secretary of State or the election commissioner or county clerk. The Secretary of State and the election 14 15 commissioner or county clerk shall make registration applications prescribed by the Secretary of State available and may place the 16 applications in public places. The Secretary of State and the 17 18 election commissioner or county clerk may require that all unused applications be returned to his or her office and may place 19 20 reasonable limits on the amount of applications requested.

- 9 precinct list of registered voters at the polling place for the
- 10 precinct in which he or she resides at a different residence address
- 11 as described in section 32-914.02, or whose name appears with a
- 12 notation that he or she received a ballot for early voting may vote a
