1 Section 1. Section 46-701, Reissue Revised Statutes of

- 3 46-701 Sections 46-701 to 46-754 <u>and section 2 of this</u>
- 4 <u>act</u>shall be known and may be cited as the Nebraska Ground Water
- 5 Management and Protection Act.
- 6 Sec. 2. (1) In order to implement its duties and
- 7 <u>obligations under the Nebraska Ground Water Management and Protection</u>
- 8 Act, each board of directors of a natural resources district that is
- 9 part of a river basin for which the district has, in accordance with
- 10 section 46-715, adopted an integrated management plan which
- 11 explicitly states the board's intent to utilize qualified projects
- 12 described in section 2-3226.04 shall, on or before January 1, 2015,
- 13 amend such integrated management plan to provide procedures to
- 14 implement and achieve district-wide and basin-wide water
- 15 sustainability by January 1, 2025. The amended integrated management
- 16 plan to achieve district-wide and basin-wide water sustainability
- 17 shall:
- 18 (a) Include the annual per-acre-inch water sustainability
- 19 <u>level;</u>
- 20 (b) Include the annual reduction in base allocation
- 21 levels divided equally over ten years that will be required to reach
- 22 water sustainability;
- (c) Clearly state that for the ensuing ten years, surface
- 24 <u>water available within the applicable area shall be used for</u>
- 25 compliance during compact-call years within those ten years;

(d) Clearly state that the maximum amount of banked or 1 2 carry-forward water that a district can allow to be carried forward over the ten years beginning on January 1, 2015, and ending December 3 4 31, 2024, shall be limited to an amount equal to one year of the base 5 allocation in the district during the 2013 irrigation season; 6 (e) Clearly state that beginning January 1, 2025, all 7 accounts of banked or carry-forward water shall be reduced to an 8 amount equal to one year of a water sustainability allocation for 9 such district and the base allocation shall become the water 10 sustainability level for each district on and after January 1, 2025, by which any new accumulation of banked or carry-forward water may 11 12 begin with a maximum amount of banked or carry-forward water not 13 exceeding the annual water sustainability level; and 14 (f) Clearly state that the director shall ensure that surface water allocations delivered to the field do not exceed ground 15 16 water allocations plus any ground water carry-forward allowed by a district to be used in any one year. 17 (2) For the purposes of this section, water 18 19 sustainability means the maximum annual amount of water per irrigated 20 acre determined and provided by the United States Geological Survey 21 which, if used as a base allocation, would sustain an area's water 22 resource levels in the short-term and the long-term. If such numbers are not available from the United States Geological Survey, such 23 maximum annual amount shall be determined and provided by the 24 Department of Natural Resources for the purposes determining water 25
