# A BILL

- 1 FOR AN ACT relating to insurance; to amend section 44-513, Reissue 2 Revised Statutes of Nebraska; to provide requirements 3 relating to pharmacists and the provision of health care 4 services; and to repeal the original section. 5
- Be it enacted by the people of the State of Nebraska,

1 Section 1. (1) Notwithstanding section 44-3,131, (a) any 2 individual or group sickness and accident insurance policy, 3 certificate, or subscriber contract delivered, issued for delivery, 4 or renewed in this state and any hospital, medical, or surgical 5 expense-incurred policy, except for short-term major medical policies 6 of six months or less duration and policies that provide coverage for 7 a specified disease or other limited-benefit coverage, and (b) any 8 self-funded employee benefit plan to the extent not preempted by 9 federal law shall recognize pharmacists as health care providers who 10 have the authority to provide health care services that include, but are not limited to, medication therapy management services, chronic 11 12 disease management services, comprehensive medication review, and 13 other such professional services provided to patients by pharmacists. 14 (2) Insurers may contract with pharmacists for the provision of services listed in subsection (1) of this section. 15 16 Payment for such services shall be separate and distinct from 17 dispensing and counseling services provided by pharmacists or as a part of a pharmacy's ordinary course of business. 18 Sec. 2. 1 which service may be legally performed by a person licensed in this

- 2 state for the practice of osteopathic medicine and surgery,
- 3 chiropractic, optometry, psychology, dentistry, pharmacy, podiatry,
- 4 or mental health practice, the person rendering such service or such
- 5 policyholder, subscriber, or other person shall be entitled to such
- 6 partial or total reimbursement, payment, or cost of such service,
- 7 whether the service is performed by a duly licensed medical doctor or
- 8 by a duly licensed osteopathic physician, chiropractor, optometrist,
- 9 psychologist, dentist, pharmacist, podiatrist, or mental health
- 10 practitioner. This section shall not limit the negotiation of
- 11 preferred provider policies and contracts under sections 44-4101 to
- 12 44-4113.
