SENATOR COASH PRESIDING

SENATOR COASH: Good morning, ladies and gentlemen. Welcome to the George W. Norris Legislative Chamber for the twenty-ninth day of the One Hundred Third Legislature, First Session. Our chaplain for today is Senator Kate Sullivan. Please rise.

SENATOR SULLIVAN: (Prayer offered.)

SENATOR COASH: Thank you, Senator Sullivan. I call to order the twenty-ninth day of the One Hundred Third Legislature, First Session. Senators, please record your presence. Mr. Clerk, please record.

CLERK: I have a quorum present, Mr. President.

SENATOR COASH: Thank you, Mr. Clerk. Are there any corrections for the Journal?

CLERK: I have no corrections.

SENATOR COASH: Thank you. Are there any messages, reports, or announcements?

CLERK: Mr. President, hearing notice from the Health and Human Services Committee signed by Senator Campbell. And I also have a confirmation hearing report from the Health Committee, also signed by Senator Campbell. That's all that I have, Mr. President. (Legislative Journal pages 479-480.)

SENATOR COASH: Thank you, Mr. Clerk. We will now proceed to the first item on the agenda.

CLERK: Mr. President, LB147 is on Select File. I do not have E&R amendments. I do have an amendment from Senator Gloor. Senator Gloor would move to amend the bill with AM161. (Legislative Journal page 387.) [LB147]

SENATOR COASH: Senator Gloor, you're recognized to open on AM161. [LB147]

SENATOR GLOOR: Thank you, Mr. President. Good morning, members, and thank you for fighting through the drifts this morning to get here to hear this exciting Select File amendment. AM161 contains cleanup amendments from LB147 that were brought to me by the Bill Drafting Office. They've also been reviewed and okayed by the Department of Insurance. The bill was introduced on behalf of the director of the

Department of Insurance. As you may recall from General File, LB147 would enact an external review system for health carriers. That would be something new for Nebraska. Federal law requires that we take this action. Federal law also requires that we change our internal review system, as is found in our existing Health Carrier Grievance Act, from a two-level to a one-level review system that's internal. We are moving as a result of the bill to an external review system. That's why the green copy of the bill would outright repeal the section of our grievance act that provides for second-level internal grievance. However, the Bill Drafters have taken a longer look at our grievance act and have found within it references to first-level and second-level grievances which, of course, means the bill would make those references obsolete and so the amendment would eliminate them. Accordingly, these amendments would insert four sections of the grievance act and amend them by striking their obsolete references to first and second-level grievance reviews because, again, under the bill there must be one level of internal review. The second level now will be external review. The amendments would also make such changes suggested by Bill Drafters in the underlying bill, internal references, and pronouns, supplying some missing words. Those are the provisions of the amendment. Again, they're all clean up. They come to us from the Bill Drafters. This should put the bill in good shape, and I would ask for your adoption of this amendment and approval of the bill. Thank you, Mr. President. [LB147]

SENATOR COASH: Senator Schumacher, you are recognized to open on AM143.

SENATOR SCHUMACHER: Thank you, Mr. President and members of the body. AM143 basically strikes Section 2 of the bill and...or excuse me, Section 4 of the bill. Section 4 allows, without any real parameters, the Department of Banking to authorize a bank to conduct business that is incidental to banking by rule or regulation. And that's about all that it says. It really doesn't explain what is incidental to banking. I've been told that that could be such things as insurance companies, travel agents, agencies, even possibly rental of airplanes. So this is a broad grant of authority to the Department of Banking to authorize banks to create limited liability companies under them with virtually no parameters. And this is part of an overall banking bill. I think that we'd be wise to do it more along the lines that it was done when they authorized banks to have subsidiary corporations, and in those particular things the Legislature in...for example, 8-148.06 specified how much money they could invest into them, how much risk they could take, specified that the businesses had to be operated in this state. When we start dealing with banking and insurance regulation, banking and insurance business, we've had a very bad experience nationally by the Congress being a little loose in its regulations, and then the regulatory agencies being worn down by the large banks to create some real mischief. Fortunately, we have not had that situation in Nebraska with our smaller banks, but if we do not take some precautionary measures and give some guidelines to the Department of Banking and lay down some rules that we feel comfortable with and have a more in-depth discussion of what we're talking about when we say that banks can create these things and do things incidental to banking, I think we're asking for trouble down the road. I think this may be a very proper subject of an independent bill by itself where the Banking Committee is thoroughly briefed on the implications on what is to be allowed, what is not to be allowed. And once you put this thing into motion, you can't get the genie back in the bottle. So I think that it would be wise to strike Section 4, let that come around again next year in the form of an independent bill, and so that we can pass it with a certain degree of comfort in that we know what we're talking about, and also meet our responsibilities to the people of Nebraska to protect the integrity of our financial institutions. It's a good bill. The amendment is an appropriate amendment to make at this point in time and as Senator Schumacher said, if it's felt necessary to further work on wording changes, we can do it next year. There is at least a reasonable suspicion that we're having things brought to us under the guise of legitimate legislative proposals when in reality, they are thinly or thickly veiled tools for the putting in place of Agenda 21. And I want Senator Kintner and the rest of the brain trust to know that I've done a little research since we had that hearing, and there is an allegation that the Obama administration are using mind-altering and controlling tactics to effect the minds of people in Legislatures in order to push through Agenda 21. Now, I'm not convinced of that yet, but I'm thinking about it. And since I haven't become convinced, I have no objection to Senator Hadley's activity here but I would advise him to go see his...whoever he takes counseling with, to see whether or not his mind is continuing to function as it should, or whether somebody has hijacked, "co-opted" it, and he is now a tool in the hands of these pernicious interests, Senator Wallman, who want to overthrow the constitutions of the United States and of Nebraska. way, as you can see in the agenda, to work our way through Select File. We'll see how far we can get with it. It would be my intention to try to get you out of here as reasonably as we can. SENATOR COASH: Thank you, Speaker Adams. Next item, Mr. Clerk.

CLERK: Mr. President, LB28, no E&R amendments. Senator Lautenbaugh would move to amend with AM330. (Legislative Journal pages 481-482.) [LB28]

SENATOR COASH: Senator Lautenbaugh, you're recognized to open on AM330. [LB28]

SENATOR LAUTENBAUGH: Thank you, Mr. President and members of the body. I just could not resist tipping my hand and here we are again talking about interest rates. What my amendment does is very simple. It adjusts the 14 percent interest rate that applies to delinquent property taxes, and curiously workers' compensation awards, from 14 percent to a fluctuating rate that hovers closer to the prevailing rate now, which is 2 or 3 percent, give or take. The sound you're hearing right now is 90-some county clerks and county assessors and treasurers hitting the NACO hot line and calling an emergency meeting. And after careful and deliberate consideration, they'll be neutral on this. (Laugh) But that said, I'm really not willing to walk away from this interest rate issue despite the fact that I will this morning in relatively short order. Yesterday, Senator Karpisek made some remarks at the microphone regarding a letter he received and I received that same letter. And I think I was the offender that was referenced in that letter, and I...and as well as others, supposedly treated a witness rudely in General Affairs Committee. And Senator Karpisek spoke about it yesterday, and I'll elaborate a bit today. I don't think I treated that witness rudely. That witness was a registered lobbyist for an organization and that witness routinely comes here and says things that are either false and known to be false to her, or she just hasn't bothered to look up the information to find out what the actual facts are year after year after year. And so she was appearing as a registered lobbyist and I questioned her, fairly pointedly, on some of her assertions because to be clear, she either didn't know what she was talking about despite this particular topic being, as she put it, her life's work these days, or she just did not care to give us the correct information. And I like to think I would do the same to any lobbyist who came before a committee and said things that I knew to be false, and he or she knew to be false. And so this is not leading, as you might surmise, to an apology at the end of this floor speech. This is me saying that there is a point at which you have enough, and I think Senator Karpisek reached that point. I think I reached that point and I think others have reached that point. If you have concerns about horse

racing and you want to come before the committee and question how the simulcast revenue is distributed, you should at least have some knowledge as to how much revenue it is and how it is actually distributed. And when someone asks you a question like, have you ever inquired as to the amount of simulcast revenue and how it's distributed, you shouldn't be surprised when you're there testifying on a horse racing bill and you start talking about simulcasting revenue. And it went on and on like that, sort of vague assertions, vague innuendos, and outright misrepresentations regarding a topic that this witness frequently comes down here and gives us the benefit of her insight on. So, no, I will not apologize and I'll probably be responding to that letter in writing as well, and I'm sure Senator Karpisek will too, because we were taken to task for being so harsh to this lobbyist. Well, folks, I'm sorry. Senator Chambers observed yesterday there's nothing in the Constitution that says people have to tell the truth, but there's nothing in the Constitution that says I have to sit there and take it either. And so, I'll not apologize for what transpired in General Affairs Committee. I'll be responding to that letter. I thank Senator Karpisek for his remarks yesterday, and at this time I'd like to withdraw, although it pains me, this interest rate amendment so that we can all avoid "Snowmageddon" and go on our way. Thank you, Mr. President. [LB28]

SENATOR COASH: Thank you, Senator Lautenbaugh. AM330 is withdrawn. Senator Hadley, you are recognized. Senator Hadley waives his opportunity. Senator Chambers, you're recognized. [LB28]

SENATOR CHAMBERS: Mr. President and members of the Legislature, on the question of lying, although the Constitution does not say that you cannot lie, the "Bible" says that all liars shall have their part in the lake of fire, so I expect to have a lot of company there with me and I'll be there for a different reason. I tell the truth but telling the truth is not enough to keep you from going there, not believing the way other people believe, will send you there. But here's what I'm concerned about and it is on the topic raised by Senator Karpisek and by Senator Lautenbaugh. They did treat a witness roughly. I cannot say inappropriately or unethically, but Senator Lautenbaugh acknowledged that he did some pointed questioning. The witness happened to be a female. And I'm not going to say that she was dealt with in the way she was because she was a female, but it ought to be clear to everybody by now that I am unashamedly, unabashedly, biased toward females because my mother was a female. My daughter is a female. The sister that I have living is a female, and the two who have died, younger than I, are females. And I think the better part of the family in the case of my mother and my two sisters were taken, and the chaff which could be expendable, myself, remains here. But that's the roll of the dice. There was a man...I'd like to ask Senator Krist a question, if I may. [LB28]

SENATOR COASH: Senator Krist, would you yield to a question? [LB28]

But he didn't. And Senator Karpisek spoke. I'm not going to say learnedly and well, but he certainly spoke energetically. Senator Lautenbaugh hitched a ride on that wagon. [LB28]

Currently in Nebraska, we screen for hearing and for metabolic and inherited disorders. This bill would simply add CCHD to the panel of newborn screenings. AM259 does not change the substance of the bill but merely provides some clarification. After adoption of the committee amendment, we were contacted by some in the medical profession with concerns that the language in Section 4(2) did not accurately describe what actually happens in a hospital setting or in a birthing facility. This amendment would strike (2) and insert new language that everybody who has been involved in this bill would agree is a workable solution. It merely states that birthing facilities must develop and implement policies that will cause the screening of a newborn. Colleagues, I ask you to adopt this amendment and to continue your support for this important bill, and please help me to move it forward to Final Reading. Thank you, colleagues. Thank you, Mr. President. [LB225]
