- 20 <u>address in this state to be entered into the system by the dispenser or</u>
- 21 <u>his or her designee daily after such prescription is dispensed, including</u>
- 22 <u>those for patients paying cash for such prescription drug or otherwise</u>
- 23 <u>not relying on a third-party payor for payment for the prescription drug;</u>
- 24 (c) Allow all prescribers or dispensers of prescription drugs to
- 25 access the system at no cost to such prescriber or dispenser; and
- 26 (d) Ensure that such system includes information relating to all
- 27 payors, including, but not limited to, the medical assistance program
