- 4 Interest Act:
- 5 (1) Authorizing statute means any statute which authorizes the
- 6 issuance of bonds;
- 7 (2) Bond means any bond, note, warrant, loan agreement, lease,
- 8 lease-purchase agreement, pledge agreement, agreement authorized by the
- 9 governing body of a generating power agency pursuant to section 2 of this
- 10 act, or other evidence of indebtedness for which a security interest is
- 11 granted or a pledge made upon revenue or other property, including any
- 12 limited tax revenue, to provide for payment or security;
- 13 (3) Governmental unit means the State of Nebraska, any county,
- 14 school district, city, village, public power district, sanitary and
- 15 improvement district, educational service unit, community college area,
- 16 natural resources district, airport authority, fire protection district,
- 17 hospital authority, joint entity created under the Interlocal Cooperation
- 18 Act, joint public agency, instrumentality, or any other district,
- 19 authority, or political subdivision of the State of Nebraska and
- 20 governmental units as defined in subdivision (a)(45) of section 9-102,
- 21 Uniform Commercial Code;
- 22 (4) Measure means any ordinance, resolution, or other enactment
- 23 authorizing the issuance of bonds or authorizing an indenture with
- 24 respect to bonds pursuant to an authorizing statute; and
- 25 (5) Owner means any holder, registered owner, or beneficial owner of
- 26 a bond.
- 27 Sec. 2. <u>(1) For purposes of this section:</u>
- 28 (a) Generating power agency has the same meaning as in Chapter 70,
- 29 <u>article 6; and</u>
- 30 (b) Regional transmission organization has the same meaning as in
- 31 section 70-1001.01.

- 1 (2) Any generating power agency buying or selling fuel, power, or
- 2 energy which operates in a regional transmission organization shall be
- 3 authorized to engage in commodity futures financial hedging transactions
- 4 with products regulated under the federal Commodity Futures Trading
- 5 Commission for fuel, power, or energy as part of its sound business
- 6 practices. Any generating power agency engaged in such transactions is
- 7 authorized to grant a foreclosable security interest in and a lien on
- 8 such agency's commodity futures account contracts or funds used for such
- 9 transactions in an amount not exceeding five percent of such agency's
- 10 annual gross revenue averaged over the preceding three calendar years.
- 11 (3) The authority to enter into agreements for the use of commodity
- 12 futures financial hedging transactions shall be authorized by a
- 13 <u>resolution adopted or an agreement approved by the governing body of the</u>
- 14 generating power agency.
- 15 (4) The authority granted in this section is limited to granting a
- 16 security interest in and a lien on future account contracts or funds
- 17 specifically designated and used for such commodity futures financial
- 18 <u>hedging transactions</u>. Except as otherwise authorized under Chapter 70,
- 19 this section does not authorize granting a foreclosable security interest
- 20 in or a lien on any other funds, assets, facilities, or property of a
- 21 <u>generating power agency.</u>
- 22 (5) An agreement authorized by this section shall be considered a
- 23 bond as defined in section 10-1103.
- 24 Sec. 3. The Revisor of Statutes shall assign section 2 of this act
- 25 to Chapter 70, article 6.
- Sec. 4. Original section 10-1103, Reissue Revised Statutes of
- 27 Nebraska, is repealed.
