- 1 A BILL FOR AN ACT relating to county government; to amend sections 2 23-1801, 23-1822, 33-139, and 48-135, Reissue Revised Statutes of 3 Nebraska, and section 33-138, Revised Statutes Cumulative 4 Supplement, 2014; to change provisions relating to the payment of 5 fees and costs associated with the deaths of incarcerated persons 6 and grand juries; to harmonize provisions; and to repeal the 7 original sections.
- 8 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. Section 23-1801, Reissue Revised Statutes of Nebraska, is
- 2 amended to read:
- 3 23-1801 (1) The coroner shall hold an inquest upon the dead bodies
- 4 of such persons only as are supposed to have died by unlawful means. When
- 5 the coroner has notice of the presence in the county of the body of a
- 6 person supposed to have died by unlawful means, the coroner may, at his
- 7 or her discretion, issue a warrant to a sheriff of the county requiring
- 8 the sheriff to summon six residents of the county to appear before the
- 9 coroner at a time and place named in the warrant.
- 10 (2) Each juror shall receive for each day employed in the discharge
- 11 of his or her duty the sum of twenty dollars to be paid by certificate
- 12 drawn by the coroner on the general funds of the county, except that when
- 13 the person supposed to have died by unlawful means died while serving a
- 14 <u>sentence in a state correctional institution, the sum shall be paid by</u>
- 15 the State of Nebraska.
- 16 (3) A juror may voluntarily waive payment under this section for his
- 17 or her service as a juror.

- 20 23-1822 In each instance when the county coroner is given notice in
- 21 accordance with section 23-1821, the coroner or coroner's physician shall

- 23 necessary to establish, by a reasonable degree of medical certainty, the
- 24 cause or causes of death and shall thereafter certify the cause or causes
- 25 of death to the presiding judge of the district court. The costs of the
- 26 <u>examination</u>, test, or autopsy shall be paid by the county in which the
- 27 person died, except that when the person died while serving a sentence in
- 28 <u>a state correctional institution, the costs shall be paid by the State of</u>
- 29 <u>Nebraska.</u>
- 30 Sec. 3. Section 33-138, Revised Statutes Cumulative Supplement,
- 31 2014, is amended to read:

- 1 33-138 (1) Each member of a grand or petit jury in a district court or county court shall receive for his or her services thirty dollars for 2 each day employed in the discharge of his or her duties prior to January 3 1, 1994, and thirty-five dollars for each such day on or after such date 4 and mileage at the rate provided in section 81-1176 for each mile 5 necessarily traveled. No juror shall be entitled to pay for the days he 6 or she is voluntarily absent or excused from service by order of the 7 court. No juror shall be entitled to pay for nonjudicial days unless 8 9 actually employed in the discharge of his or her duties as a juror on 10 such days.
- (2) In the event that any temporary release from service, other than that obtained by the request of a juror, shall occasion an extra trip or trips to and from the residence of any juror or jurors the court may, by special order, allow mileage for such extra trip or trips.

 16 shall be made by the county, except that in a case before a grand jury
 17 involving the death of an inmate who died while serving a sentence in a
 18 state correctional institution, payment shall be made by the State of
 19 Nebraska.
- 20 (4) A juror may voluntarily waive payment under this section for his 21 or her service as a juror.
- Sec. 4. Section 33-139, Reissue Revised Statutes of Nebraska, is amended to read:
- 24 33-139 Witnesses before the district court and the county court, except the Small Claims Court, and the grand jury shall receive twenty 25 dollars, and witnesses before the Small Claims Court shall receive eight 26 dollars, for each day actually employed in attendance on the court or 27 grand jury, and if the witness shall reside more than one mile from the 28 courthouse or place where the court is held, he or she shall receive 29 mileage at the rate provided in section 81-1176 for state employees for 30 each mile necessarily traveled. Such compensation shall be paid by the 31

- 2 <u>an inmate who died while serving a sentence in a state correctional</u>
- 3 institution, witness compensation shall be paid by the State of Nebraska.

- 6 48-135 Except as provided in sections 23-1822 and section 23-1824,
- 7 in all death claims, where the cause of death is obscure or disputed, any
- 8 interested party may require an autopsy, the cost of such autopsy to be
- 9 borne by the party demanding the same.

- 11 Reissue Revised Statutes of Nebraska, and section 33-138, Revised
- 12 Statutes Cumulative Supplement, 2014, are repealed.
