## **LEGISLATIVE BILL 265A**

- 1 A BILL FOR AN ACT relating to appropriations; to appropriate funds to aid
- 2 in carrying out the provisions of Legislative Bill 265, One Hundred
- 3 Fourth Legislature, First Session, 2015; and to reduce an
- 4 appropriation.
- 5 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. There is hereby appropriated (1) \$150,000 from the
- 2 General Fund for FY2015-16 and (2) \$150,000 from the General Fund for
- 3 FY2016-17 to the Supreme Court, for Program 435, to aid in carrying out
- 4 the provisions of Legislative Bill 265, One Hundred Fourth Legislature,
- 5 First Session, 2015.
- 6 No expenditures for permanent and temporary salaries and per diems
- 7 for state employees shall be made from funds appropriated in this
- 8 section.
- 9 Sec. 2. There is hereby appropriated (1) \$109,919 from the General
- 10 Fund for FY2015-16 and (2) \$131,904 from the General Fund for FY2016-17
- 11 <u>to the Department of Health and Human Services, for Program 33, to aid in</u>
- 12 <u>carrying out the provisions of Legislative Bill 265, One Hundred Fourth</u>
- 13 <u>Legislature</u>, First Session, 2015.
- 14 Total expenditures for permanent and temporary salaries and per
- 15 diems from funds appropriated in this section shall not exceed \$62,157
- 16 for FY2015-16 or \$74,589 for FY2016-17.
- 17 Sec. 3. There is hereby appropriated (1) \$414,048 from the General
- 18 Fund for FY2015-16 and (2) \$496,857 from the General Fund for FY2016-17
- 19 to the Department of Health and Human Services, for Program 354, to aid
- 20 <u>in carrying out the provisions of Legislative Bill 265, One Hundred</u>
- 21 Fourth Legislature, First Session, 2015.
- 22 There is included in the appropriation to this program for FY2015-16
- 23 \$414,048 General Funds for state aid, which shall only be used for such
- 24 purpose. There is included in the appropriation to this program for
- 25 FY2016-17 \$496,857 General Funds for state aid, which shall only be used
- for such purpose.
- 27 No expenditures for permanent and temporary salaries and per diems
- 28 for state employees shall be made from funds appropriated in this
- 29 <u>section</u>.
- 30 Sec. 4. There is hereby appropriated (1) \$263,732 from the General
- 31 Fund and \$87,911 from federal funds for FY2015-16 and (2) \$259,232 from

- 1 the General Fund and \$86,411 from federal funds for FY2016-17 to the
- 2 Foster Care Review Office, for Program 116, to aid in carrying out the
- 3 provisions of Legislative Bill 265, One Hundred Fourth Legislature, First
- 4 Session, 2015.
- 5 Total expenditures for permanent and temporary salaries and per
- 6 diems from funds appropriated in this section shall not exceed \$178,875
- 7 for FY2015-16 or \$178,875 for FY2016-17.
- 8 Sec. 5. There is hereby appropriated (1) \$688,578 from the General
- 9 Fund for FY2015-16 and (2) \$988,578 from the General Fund for FY2016-17
- 10 to the Nebraska Commission on Law Enforcement and Criminal Justice, for
- 11 Program 155, to aid in carrying out the provisions of Legislative Bill
- 12 <u>265, One Hundred Fourth Legislature, First Session, 2015.</u>
- 13 <u>Total expenditures for permanent and temporary salaries and per</u>
- 14 diems from funds appropriated in this section shall not exceed \$46,587
- 15 for FY2015-16 or \$47,705 for FY2016-17.
- 16 The Nebraska Commission on Law Enforcement and Criminal Justice
- 17 shall contract with the University of Nebraska at Omaha, Juvenile Justice
- 18 Institute for \$206,574 in FY2015-16 and \$395,431 in FY2016-17. These
- 19 amounts represent the percentages that the University of Nebraska at
- 20 Omaha, Juvenile Justice Institute, is to receive as specified in
- 21 Legislative Bill 265, One Hundred Fourth Legislature, First Session,
- 22 2015.
- 23 Sec. 6. <u>The appropriation to the Nebraska Commission on Law</u>
- 24 Enforcement and Criminal Justice, for Program 155, is hereby reduced by
- 25 \$688,578 General Funds for FY2015-16 and by \$988,578 General Funds for
- 26 <u>FY2016-17</u>, to aid in carrying out the provisions of Legislative Bill 265,
- 27 <u>One Hundred Fourth Legislature, First Session, 2015.</u>
- It is the intent of the Legislature that the reductions contained in
- 29 this section shall reduce the amount allocated for state aid by \$688,578
- 30 General Funds for FY2015-16 and by \$988,578 General Funds for FY2016-17.
