LEGISLATIVE BILL 472A

Introduced by Campbell, 25.

Read first time March 26, 2015

- 1 A BILL FOR AN ACT relating to appropriations; to appropriate funds to aid
2 in carrying out the provisions of Legislative Bill 472, One Hundred
3 Fourth Legislature, First Session, 2015; and to reduce
4 appropriations.
5 Be it enacted by the people of the State of Nebraska,

1 Section 1. There is hereby appropriated (1) \$116,776 from the
2 Department of Insurance Cash Fund for FY2015-16 and (2) \$149,326 from the
3 Department of Insurance Cash Fund for FY2016-17 to the Department of
4 Insurance, for Program 69, to aid in carrying out the provisions of
5 Legislative Bill 472, One Hundred Fourth Legislature, First Session,
6 2015.

7 Total expenditures for permanent and temporary salaries and per
8 diems from funds appropriated in this section shall not exceed \$72,485
9 for FY2015-16 or \$95,671 for FY2016-17.

10 Sec. 2. There is hereby appropriated (1) \$6,538,394 from the
11 General Fund and \$13,285,739 from federal funds for FY2015-16 and (2)
12 \$5,955,261 from the General Fund and \$13,512,380 from federal funds for
13 FY2016-17 to the Department of Health and Human Services, for Program 33,
14 to aid in carrying out the provisions of Legislative Bill 472, One
15 Hundred Fourth Legislature, First Session, 2015.

16 Total expenditures for permanent and temporary salaries and per
17 diems from funds appropriated in this section shall not exceed
18 \$10,164,936 for FY2015-16 or \$13,192,269 for FY2016-17.

19 Sec. 3. There is hereby appropriated (1) \$432,539,764 from federal
20 funds for FY2015-16 and (2) \$11,027,570 from the General Fund and
21 \$430,075,227 from federal funds for FY2016-17 to the Department of Health
22 and Human Services, for Program 349, to aid in carrying out the
23 provisions of Legislative Bill 472, One Hundred Fourth Legislature, First
24 Session, 2015.

25 No expenditures for permanent and temporary salaries and per diems
26 for state employees shall be made from funds appropriated in this
27 section.

28 Sec. 4. The General Fund appropriation for FY2015-16 to the
29 Department of Health and Human Services, for Program 38, is hereby
30 reduced by \$1,000,000. The General Fund appropriation for FY2016-17 to
31 the Department of Health and Human Services, for Program 38, is hereby

1 reduced by \$2,000,000.

2 Sec. 5. The General Fund appropriation for FY2015-16 to the
3 Department of Health and Human Services, for Program 347, is hereby
4 reduced by \$7,583,333. The General Fund appropriation for FY2016-17 to
5 the Department of Health and Human Services, for Program 347, is hereby
6 reduced by \$9,100,000.

7 Sec. 6. The General Fund appropriation for FY2015-16 to the
8 Department of Health and Human Services, for Program 514, is hereby
9 reduced by \$750,000. The General Fund appropriation for FY2016-17 to the
10 Department of Health and Human Services, for Program 514, is hereby
11 reduced by \$900,000.

12 Sec. 7. The General Fund appropriation for FY2015-16 to the
13 Department of Correctional Services, for Program 200, is hereby reduced
14 by \$729,616. The General Fund appropriation for FY2016-17 to the
15 Department of Correctional Services, for Program 200, is hereby reduced
16 by \$729,616.
