- 1 A BILL FOR AN ACT relating to insurance; to amend section 44-3805,
- 2 Reissue Revised Statutes of Nebraska, and section 44-7,105, Revised
- 3 Statutes Cumulative Supplement, 2014; to change provisions relating
- 4 to dental services; and to repeal the original sections.
- 5 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. Section 44-7,105, Revised Statutes Cumulative Supplement,
- 2 2014, is amended to read:
- 3 44-7,105 (1) Notwithstanding section 44-3,131, (a  $\pm$ ) an individual
- 4 or group sickness or accident policy, certificate, or subscriber contract
- 5 delivered, issued for delivery, or renewed in this state and a hospital,
- 6 medical, or surgical expense-incurred policy,  $(\underline{b} + 2)$  a self-funded
- 7 employee benefit plan to the extent not preempted by federal law, and (c
- 8 3) a certificate, agreement, or contract to provide limited health
- 9 services issued by a prepaid limited health service organization as
- 10 defined in section 44-4702 shall not include a provision, stipulation, or
- 11 agreement establishing or limiting any fees charged for dental services
- 12 that are not covered by the policy, certificate, contract, agreement, or
- 13 plan.
- 14 (2) For purposes of this section, dental services are considered to
- 15 be covered by a policy, certificate, contract, agreement, or plan if the
- 16 <u>service is one for which full reimbursement is actually provided on a</u>
- 17 given claim under the applicable policy, certificate, contract,
- 18 <u>agreement</u>, or plan.
- 19 (3) This section does not prohibit a policy, certificate, contract,
- 20 <u>agreement, or plan that does not cover a specific dental service from</u>
- 21 offering the insured, enrollee, or subscriber an alternate benefit, and
- 22 in such case the dentist may bill the insured, enrollee, or subscriber
- 23 for the difference between the dentist's fee for the specific dental
- 24 <u>service provided and the alternate benefit.</u>
- 25 Sec. 2. Section 44-3805, Reissue Revised Statutes of Nebraska, is
- 26 amended to read:
- 27 44-3805 (1) A prepaid dental service plan may be offered on an
- 28 individual or group basis. Each person covered under a group contract
- 29 shall be issued a certificate of coverage.
- 30 (2) No contract or certificate for dental service may be issued in
- 31 this state unless a copy of the form has been filed with and approved by

- 1 the director.
- 2 (3)(a) No prepaid dental service plan offered in this state shall
- 3 limit any fees charged for services that are not covered by the plan.
- 4 (b) For purposes of this subsection, dental services are considered
- 5 to be covered by a prepaid dental service plan if the service is one for
- 6 which full reimbursement is actually provided on a given claim under the
- 7 applicable plan.
- 8 (4) This section does not prohibit a prepaid dental service plan
- 9 that does not cover a specific dental service from offering the person
- 10 covered under the plan an alternate benefit, and in such case the dentist
- 11 may bill the person covered under the plan for the difference between the
- 12 <u>dentist's fee for the specific dental service provided and the alternate</u>
- 13 benefit.
