- 1 A BILL FOR AN ACT relating to appropriations; to appropriate funds to aid
- 2 in carrying out the provisions of Legislative Bill 598, One Hundred
- 3 Fourth Legislature, First Session, 2015; and to reduce
- 4 appropriations.
- 5 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. There is hereby appropriated (1) \$86,468 from the
- 2 General Fund for FY2015-16 and (2) \$85,831 from the General Fund for
- 3 FY2016-17 to the Legislative Council, for Program 504 Office of Public
- 4 Counsel, to aid in carrying out the provisions of Legislative Bill 598,
- 5 One Hundred Fourth Legislature, First Session, 2015.
- 6 Total expenditures for permanent and temporary salaries and per
- 7 diems from funds appropriated in this section shall not exceed \$66,114
- 8 for FY2015-16 or \$67,701 for FY2016-17.
- 9 Sec. 2. There is hereby appropriated (1) \$790,666 from the General
- 10 Fund and \$-0- from the Parole Program Cash Fund for FY2015-16 and (2)
- 11 \$5,040,242 from the General Fund and \$455,873 from the Parole Program
- 12 <u>Cash Fund for FY2016-17 to the Board of Pardons and Board of Parole, for</u>
- 13 Program 358, to aid in carrying out the provisions of Legislative Bill
- 14 598, One Hundred Fourth Legislature, First Session, 2015.
- 15 <u>Total expenditures for permanent and temporary salaries and per</u>
- 16 diems from funds appropriated in this section shall not exceed \$539,164
- 17 for FY2015-16 or \$2,995,911 for FY2016-17.
- 18 There is included in the appropriation to this program for FY2015-16
- 19 \$100,000 General Funds which shall only be used by the Board of Parole to
- 20 <u>develop and implement a strategic plan to transition the supervision of</u>
- 21 the Office of Parole Administration from the Department of Correctional
- 22 Services to the Board of Parole. For the purposes of developing such a
- 23 plan, the Board of Parole shall, on or before January 1, 2016, hire a
- 24 transition plan director and any staff as allowed under subsection (2) of
- 25 section 83-188 to assist such director in the transition.
- Sec. 3. There is hereby appropriated (1) \$635,463 from the General
- 27 Fund for FY2015-16 and (2) \$-0- from the General Fund for FY2016-17 to
- 28 the Department of Correctional Services, for Program 200, to aid in
- 29 carrying out the provisions of Legislative Bill 598, One Hundred Fourth
- 30 <u>Legislature</u>, First Session, 2015.
- 31 Total expenditures for permanent and temporary salaries and per

- 1 diems from funds appropriated in this section shall not exceed \$411,739
- 2 for FY2015-16 or \$-0- for FY2016-17.
- 3 Sec. 4. The General Fund appropriation for FY2015-16 to the
- 4 Department of Correctional Services, for Program 200, is hereby reduced
- 5 by \$-0-.
- 6 The General Fund appropriation for FY2016-17 to the Department of
- 7 Correctional Services, for Program 200, is hereby reduced by \$3,484,339.
- 8 The Salary Limit for FY2016-17 to the Department of Correctional
- 9 Services, for Program 200, is hereby reduced by \$1,957,336.
- 10 The reductions made pursuant to this section are to aid in carrying
- 11 <u>out the provisions of Legislative Bill 598, One Hundred Fourth</u>
- 12 <u>Legislature, First Session, 2015.</u>
- 13 Sec. 5. The Cash Fund appropriation for FY2015-16 to the Department
- 14 of Correctional Services, for Program 367, is hereby reduced by \$-0-.
- 15 The Cash Fund appropriation for FY2016-17 to the Department of
- 16 Correctional Services, for Program 367, is hereby reduced by \$455,873.
