- A BILL FOR AN ACT relating to game and parks; to amend section 37-406, Reissue Revised Statutes of Nebraska, and sections 37-327, 37-405,
- 3 37-407, 37-415, 37-420, 37-421, 37-421.01, 37-426, 37-438, 37-447,

37-449, 37-450, 37-451, 37-457, 37-484, 37-490, 37-497, and

change license, permit, stamp, and application fees as prescribed;

- 5 37-4,111, Revised Statutes Cumulative Supplement, 2014; to change
- 6 the limit for increasing fees by the Game and Parks Commission; to
- 7 change provisions relating to permits and permit applications; to
- 9 and to repeal the original sections.
- 10 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. Section 37-327, Revised Statutes Cumulative Supplement,
- 2 2014, is amended to read:
- 3 37-327 (1) The commission shall establish fees for licenses,
- 4 permits, stamps, bands, registrations, and certificates issued under the
- 5 Game Law and the State Boat Act as provided in the Game Law and State
- 6 Boat Act. The commission shall not increase any fee more than six percent
- 7 per year, except that if a fee has not been increased by such percentage
- 8 in the immediately preceding two years year, the difference between a six
- 9 percent increase and the actual percentage increase in such preceding two
- 10 years year may be added to the percentage increase in the following year.
- 11 Such fees shall be collected and disposed of as provided in the Game Law
- 12 and State Boat Act. The commission shall, as provided in the Game Law and
- 13 State Boat Act, establish issuance fees to be retained by authorized
- 14 agents issuing such licenses, permits, stamps, bands, registrations, and
- 15 certificates. The commission shall establish such fees by the adoption
- 16 and promulgation of rules and regulations.
- 17 (2) Prior to establishing any fee, the commission shall, at least
- 18 thirty days prior to the hearing required in section 84-907, make the
- 19 following information available for public review:
- 20 (a) The commission's policy on the minimum cash balance to be
- 21 maintained in the fund in which the revenue from the fee being
- 22 established is deposited and the justification in support of such policy;
- 23 (b) Monthly estimates of cash fund revenue, expenditures, and ending
- 24 balances for the current fiscal year and the following two fiscal years
- 25 for the fund in which the revenue from the fee being established is
- 26 deposited. Estimates shall be prepared for both the current fee schedule
- 27 and the proposed fee schedule; and
- (c) A statement of the reasons for establishing the fee at the
- 29 proposed level.
- 30 (3) The commission may adopt and promulgate rules and regulations to
- 31 establish fees for expired licenses, permits, stamps, bands,

- 1 registrations, and certificates issued under the Game Law and the State
- 2 Boat Act. The commission shall collect the fees and remit them to the
- 3 State Treasurer for credit to the State Game Fund.
- 4 Sec. 2. Section 37-405, Revised Statutes Cumulative Supplement,
- 5 2014, is amended to read:
- 6 37-405 (1) The commission shall provide for the issuance of permits
- 7 to hunt, fish, or harvest fur. Application for such permits shall be made
- 8 to the commission or its agents and shall contain such information as may
- 9 be prescribed by the commission. All applications for permits to harvest
- 10 fur shall include the applicant's last four digits of his or her social
- 11 security number. A permit shall authorize the person to whom it is issued
- 12 to hunt, fish, or harvest fur-bearing animals as provided by the Game Law
- 13 during the period for which the permit is issued.
- 14 (2) If the holder of a hunting permit is a hunter of migratory game
- 15 birds, he or she shall be required to declare himself or herself as such
- 16 and provide information regarding his or her migratory game bird hunting
- 17 activity to the commission. Documentation of such a declaration shall be
- 18 made on the hunting permit or a separate document which shall become a
- 19 part of the permit. Costs to the commission of implementing such
- 20 declaration and documentation and for participation in a federal program
- 21 designed to obtain survey information on migratory bird hunting activity
- 22 shall be funded from the State Game Fund. For purposes of this
- 23 subsection, migratory bird has the definition found in 50 C.F.R. part 10,
- 24 subpart B, section 10.12, and migratory game bird has the definition
- 25 found in 50 C.F.R. part 20, subpart B, section 20.11(a).
- 26 (3)(a) All permits shall expire at midnight on December 31 in the
- 27 year for which the permit is issued, except as otherwise provided in
- 28 subdivision (b) of this subsection and sections 37-415, 37-420, and
- 29 37-421.
- 30 (b) The commission may issue multiple-year permits to hunt, fish, or
- 31 harvest fur. The permits shall expire at midnight on December 31 in the

- 1 last year for which the permit is valid.
- 2 (c) A multiple-year permit issued to a resident of Nebraska shall
- 3 not be made invalid by reason of the holder subsequently residing outside
- 4 of Nebraska.
- 5 (4) A person who is hunting, fur harvesting, or fishing shall
- 6 present evidence of having a permit immediately upon demand to any
- 7 officer or person whose duty it is to enforce the Game Law. Any person
- 8 hunting, fishing, or fur harvesting in this state without such evidence
- 9 shall be deemed to be without such permit.
- 10 (5) The commission shall adopt and promulgate rules and regulations
- 11 necessary to carry out this section.
- 12 Sec. 3. Section 37-406, Reissue Revised Statutes of Nebraska, is
- 13 amended to read:
- 14 37-406 (1) Licenses, permits, and stamps required under the Game Law
- 15 shall be issued by the commission and may be procured from the secretary
- 16 of the commission. The commission may provide for the electronic issuance
- 17 of any license, permit, or stamp required under the Game Law and may
- 18 enter into contracts to procure necessary services and supplies for the
- 19 electronic issuance of licenses, permits, and stamps. Except for permits
- 20 issued under sections 37-462 and 37-463, the commission may provide for
- 21 the issuance of any license, permit, or stamp required under the Game Law
- 22 in the form of a number which identifies the holder in the records of the
- 23 commission. The commission may designate itself and other persons, firms,
- 24 and corporations as agents to issue licenses, permits, and stamps and
- 25 collect the prescribed fees. The commission and any person, firm, or
- 26 corporation authorized by the commission to issue licenses, permits, and
- 27 stamps shall be entitled to collect and retain an additional fee of not
- 28 less than fifty cents and not more than three two dollars, for each
- 29 license, permit, or stamp issued as reimbursement for the clerical work
- 30 of issuing the license, permit, or stamp and collecting and remitting the

- 1 (2) The commission shall adopt and promulgate rules and regulations
- 2 regarding electronic issuance of licenses, permits, and stamps, including
- 3 electronic issuance devices, deposits by agents, and remittance of fees.
- 4 The commission may provide for the electronic issuance of a license,
- 5 permit, or stamp by acknowledging the purchase of such license, permit,
- 6 or stamp without requiring a physical license, permit, or stamp or
- 7 facsimile of such.
- 8 (3) It shall be unlawful for any person to duplicate any
- 9 electronically issued license, permit, or stamp. Any person violating
- 10 this subsection shall be guilty of a Class III misdemeanor and shall be
- 11 fined at least seventy-five dollars, and any license, permit, or stamp
- 12 involved in such violation shall be confiscated by the court.
- 13 Sec. 4. Section 37-407, Revised Statutes Cumulative Supplement,
- 14 2014, is amended to read:
- 15 37-407 (1) The commission may offer multiple-year permits or
- 16 combinations of permits at reduced rates and may establish fees pursuant
- 17 to section 37-327 to be paid to the state for resident and nonresident
- 18 annual hunting permits, annual fishing permits, three-day fishing
- 19 permits, one-day fishing permits, combination hunting and fishing
- 20 permits, fur-harvesting permits, and nonresident two-day hunting permits
- 21 issued for periods of two consecutive days, as provided in this section.
- 22 (2) The fee for a multiple-year permit shall be established by the
- 23 commission pursuant to section 37-327 and shall not be more than the
- 24 number of years the permit will be valid times the fee required for an
- 25 annual permit as provided in subsection (3) or (4) of this section.
- 26 Payment for a multiple-year permit shall be made in a lump sum at the
- 27 time of application. A replacement multiple-year permit may be issued

- 5 annual fur harvesting permit.
- 6 (4) Nonresident fees shall be (a) not more than two hundred sixty
- 7 dollars for a period of time specified by the commission for fur
- 8 harvesting one thousand or less fur-bearing animals and not more than

- 10 of one hundred fur-bearing animals harvested, (b)(i) for persons sixteen

- 29 fishing permit upon application and payment of the appropriate fee. The
- 30 fee for a resident lifetime fur-harvesting permit shall be not more than
- 31 two hundred ninety-nine dollars, the fee for a resident lifetime hunting

- 1 permit shall be not more than three hundred ninety-six two hundred
- 2 ninety-nine dollars, the fee for a resident lifetime fishing permit shall
- 3 be not more than <u>four hundred fifty-seven</u> three hundred forty-five
- 4 dollars plus the cost of a lifetime aquatic habitat stamp, and the fee
- 5 for a resident lifetime combination hunting and fishing permit shall be
- 6 not more than <u>seven hundred ninety-two</u> five hundred ninety-eight dollars

- 14 payment of the appropriate fee. The fee for a nonresident lifetime
- 15 hunting permit shall be not more than one thousand five hundred sixty-two
- 16 twelve hundred fifty dollars, the fee for a nonresident lifetime fishing
- 17 permit shall be not more than one thousand one hundred twenty-five eight
- 18 hundred fifty dollars plus the cost of a lifetime aquatic habitat stamp,
- 19 and the fee for a nonresident lifetime combination hunting and fishing
- 20 permit shall be not more than two thousand three hundred forty-two two
- 21 thousand dollars plus the cost of a lifetime aquatic habitat stamp, as
- 22 such fees are established by the commission pursuant to section 37-327.
- 23 Payment of the fee shall be made in a lump sum at the time of
- 24 application.
- 25 (4) A replacement resident or nonresident lifetime permit may be
- 26 issued if the original has been lost or destroyed. The fee for a
- 27 replacement shall be not less than one dollar and fifty cents and not
- 28 more than five dollars, as established by the commission.
- 29 (5) The commission may adopt and promulgate rules and regulations to
- 30 carry out this section and sections 37-416 and 37-417. Such rules and
- 31 regulations may include, but need not be limited to, establishing fees

- 3 2014, is amended to read:
- 4 37-420 (1) Any veteran who is a legal resident of the State of
- 5 Nebraska shall, upon application and without payment of any fee, be
- 6 issued a combination fishing, fur harvesting, and hunting permit, habitat
- 7 stamp, aquatic habitat stamp, and Nebraska migratory waterfowl stamp if
- 8 the veteran:
- 9 (a) Was discharged or separated with a characterization of honorable
- 10 or general (under honorable conditions); and
- 11 (b)(i) Is rated by the United States Department of Veterans Affairs
- 12 as fifty percent or more disabled as a result of service in the armed
- 13 forces of the United States; or
- 14 (ii) Is receiving a pension from the department as a result of total
- 15 and permanent disability, which disability was not incurred in the line

- 30 Sec. 7. Section 37-421, Revised Statutes Cumulative Supplement,

- 1 37-421 (1) The commission may issue an annual combination fishing,
- 2 fur harvesting, and hunting permit, habitat stamp, aquatic habitat stamp,
- 3 and Nebraska migratory waterfowl stamp upon application and payment of a
- 4 fee of five dollars to (a) any Nebraska resident who is a veteran, who is
- 5 sixty-four years of age or older, and who was discharged or separated
- 6 with a characterization of honorable or general (under honorable

- 25 twelve months at the time of application shall be entitled to receive an
- 26 annual combination fishing, fur harvesting, and hunting permit, habitat
- 27 stamp, aquatic habitat stamp, and Nebraska migratory waterfowl stamp on a
- 28 one-time basis upon returning to the state if the resident:

- 8 (c) No resident of Nebraska sixteen years of age or older and no 9 nonresident of Nebraska regardless of age shall hunt, harvest, or possess 10 any migratory waterfowl unless, at the time of such hunting, harvesting, 11 or possessing, such person has an unexpired Nebraska migratory waterfowl 12 stamp as prescribed by the rules and regulations of the commission prior 13 to the time of hunting, harvesting, or possessing such migratory 14 waterfowl.
- (2)(a) The commission may issue a lifetime habitat stamp upon 15 16 application and payment of the appropriate fee. The fee for a lifetime habitat stamp shall be twenty times the fee required in subsection (5) of 17 this section for an annual habitat stamp. Payment of such fee shall be 18 made in a lump sum at the time of application. A replacement lifetime 19 habitat stamp may be issued if the original is lost or destroyed. The fee 20 for a replacement shall be not more than five dollars, as established by 21 22 the commission.
- 23 (b) The commission may issue a lifetime Nebraska migratory waterfowl 24 stamp upon application and payment of the appropriate fee. The fee for a lifetime Nebraska migratory waterfowl stamp shall be twenty times the fee 25 required in subsection (5) of this section for an annual Nebraska 26 migratory waterfowl stamp. Payment of such fee shall be made in a lump 27 sum at the time of application. A replacement Nebraska lifetime migratory 28 waterfowl stamp may be issued if the original is lost or destroyed. The 29 fee for a replacement shall be not more than five dollars, as established 30 31 by the commission.

- 1 (c) The commission may issue a lifetime aquatic habitat stamp upon 2 application and payment of the appropriate fee. The fee for a lifetime aquatic habitat stamp shall be twenty times the fee required in 3 subdivision (5)(c) of this section for an annual aquatic habitat stamp 4 5 not more than two hundred dollars as established by the commission pursuant to section 37-327. Payment of such fee shall be made in a lump 6 7 sum at the time of application. A replacement lifetime aquatic habitat 8 stamp may be issued if the original is lost or destroyed. The fee for a 9 replacement shall be not more than five dollars, as established by the commission. 10
- (3)(a) The commission may issue a multiple-year habitat stamp upon 11 12 application and payment of the appropriate fee. The fee for a multipleyear habitat stamp shall be established by the commission pursuant to 13 section 37-327 and shall not be more than the number of years the stamp 14 is valid times the fee required in subsection (5) of this section for an 15 16 annual habitat stamp. Payment of such fee shall be made in a lump sum at 17 the time of application. A replacement multiple-year habitat stamp may be issued if the original is lost or destroyed. 18
- 19 (b) The commission may issue a multiple-year Nebraska migratory waterfowl stamp upon application and payment of the appropriate fee. The 20 fee for a multiple-year Nebraska migratory waterfowl stamp shall be 21 established by the commission pursuant to section 37-327 and shall not be 22 23 more than the number of years the stamp is valid times the fee required 24 in subsection (5) of this section for an annual Nebraska migratory waterfowl stamp. Payment of such fee shall be made in a lump sum at the 25 time of application. A replacement Nebraska multiple-year migratory 26 waterfowl stamp may be issued if the original is lost or destroyed. 27
- (c) The commission may issue a multiple-year aquatic habitat stamp upon application and payment of the appropriate fee. The fee for a multiple-year aquatic habitat stamp shall be established by the commission pursuant to section 37-327 and shall not be more than the

- 1 number of years the stamp is valid times the fee required in subsection
- 2 (5) of this section for an annual aquatic habitat stamp. Payment of such
- 3 fee shall be made in a lump sum at the time of application. A replacement
- 4 multiple-year aquatic habitat stamp may be issued if the original is lost
- 5 or destroyed.
- 6 (4) Habitat stamps are not required for holders of limited permits
- 7 issued under section 37-455. Aquatic habitat stamps are not required (a)
- 8 when a fishing permit is not required, (b) for holders of permits
- 9 pursuant to section 37-424, or (c) for holders of lifetime fishing
- 10 permits or lifetime combination hunting and fishing permits purchased
- 11 prior to January 1, 2006. Nebraska migratory waterfowl stamps are not
- 12 required for hunting, harvesting, or possessing any species other than
- 13 ducks, geese, or brant. For purposes of this section, a showing of proof
- of the electronic issuance of a stamp by the commission shall fulfill the
- 15 requirements of this section.
- 16 (5)(a) Any person to whom a stamp has been issued shall, immediately
- 17 upon request, exhibit evidence of issuance of the stamp to any officer.
- 18 Any person hunting, fishing, harvesting, or possessing any game bird,
- 19 upland game bird, game animal, or fur-bearing animal or any aquatic
- 20 organism requiring a fishing permit in this state without evidence of

- 23 (b) An annual habitat stamp shall be issued upon the payment of a
- 24 fee of <u>twenty-five</u> <del>twenty</del> dollars per stamp. A multiple-year habitat
- 25 stamp shall be issued in conjunction with a multiple-year hunting permit
- or a multiple-year combination hunting and fishing permit at a fee of not
- 27 more than twenty-five twenty dollars times the number of years the
- 28 multiple-year permit is valid.
- 29 (c) An aquatic habitat stamp shall be issued in conjunction with
- 30 each fishing permit for a fee of <u>fifteen</u> ten dollars per stamp for annual
- 31 fishing permits, three-day fishing permits, or combination hunting and

- 1 fishing permits, a fee of not more than <u>fifteen</u> ten dollars times the
- 2 number of years the multiple-year fishing permit or a multiple-year
- 3 combination hunting and fishing permit is valid, and a fee of not more
- 4 than <u>twenty times the fee required for an annual aquatic habitat stamp</u>
- 5 two hundred dollars for lifetime fishing or combination hunting and
- 6 fishing permits. The fee established under section 37-407 for a one-day
- 7 fishing permit shall include an aquatic habitat stamp. One dollar from
- 8 the sale of each one-day fishing permit shall be remitted to the State
- 9 Treasurer for credit to the Nebraska Aquatic Habitat Fund.
- 10 (d) An annual Nebraska migratory waterfowl stamp shall be issued
- 11 upon the payment of a fee of <u>not less than ten dollars and not more than</u>
