- 1 Section 1. There is hereby appropriated (1) \$784,972 from the
- 2 General Fund and \$784,972 from federal funds for FY2015-16 and (2)
- 3 \$739,262 from the General Fund and \$739,262 from federal funds for
- 4 FY2016-17 to the Department of Health and Human Services, for Program 33,
- 5 <u>to aid in carrying out the provisions of Legislative Bill 77, One Hundred</u>
- 6 Fourth Legislature, First Session, 2015.
- 7 <u>Total expenditures for permanent and temporary salaries and per</u>
- 8 <u>diems from funds appropriated in this section shall not exceed \$1,011,302</u>
- 9 for FY2015-16 or \$1,011,302 for FY2016-17.
- Sec. 2. There is hereby appropriated \$680,400 from the General Fund
- 11 and \$6,123,600 from federal funds for FY2015-16 to the Department of
- 12 <u>Health and Human Services, for Program 348, to aid in carrying out the</u>
- 13 provisions of Legislative Bill 77, One Hundred Fourth Legislature, First
- 14 <u>Session</u>, 2015.
- No expenditures for permanent and temporary salaries and per diems
- 16 <u>for state employees shall be made from funds appropriated in this</u>
- 17 section.
- Sec. 3. There is hereby appropriated (1) \$500,000 from the General
- 19 Fund for FY2015-16 and (2) \$500,000 from the General Fund for FY2016-17
- 20 to the Department of Health and Human Services, for Program 514, to aid
- 21 <u>in carrying out the provisions of Legislative Bill 77, One Hundred Fourth</u>
- 22 Legislature, First Session, 2015.
- 23 <u>No expenditures for permanent and temporary salaries and per diems</u>
- 24 for state employees shall be made from funds appropriated in this
- 25 <u>section.</u>
- 26 Sec. 4. <u>The General Fund appropriation for FY2016-17 to the</u>
- 27 <u>Department of Health and Human Services, for Program 348, is hereby</u>
- 28 reduced by \$13,176,817. The federal funds estimated appropriation for
- 29 FY2016-17 to the Department of Health and Human Services, for Program
- 30 <u>348</u>, is hereby reduced by \$8,391,863.
- 31 Sec. 5. Since an emergency exists, this act takes effect when

1 passed and approved according to law.
