- 1 A BILL FOR AN ACT relating to the Uniform Disposition of Unclaimed
- 2 Property Act; to amend section 69-1329, Revised Statutes Cumulative
- 3 Supplement, 2014; to authorize escheatment to the state of unclaimed
- 4 United States Savings Bonds as prescribed; to harmonize provisions;
- 5 and to repeal the original section.
- 6 Be it enacted by the people of the State of Nebraska,

LB873 2016

- 1 Section 1. (a)(1) United States Savings Bonds which are unclaimed
- 2 property and subject to the Uniform Disposition of Unclaimed Property Act
- 3 shall escheat to the State of Nebraska five years after becoming
- 4 unclaimed property and subject to the act and all property rights to such
- 5 United States Savings Bonds or proceeds from such bonds shall vest solely
- 6 in the State of Nebraska.
- 7 (2) Within one hundred eighty days after the five-year time period
- 8 set forth in subdivision (a)(1) of this section, if no claim has been
- 9 filed in accordance with the act for such United States Savings Bonds,
- 10 the State Treasurer shall commence a civil action in the district court
- 11 <u>of Lancaster County for a determination that such United States Savings</u>
- 12 <u>Bonds shall escheat to the state. The State Treasurer may postpone the</u>
- 13 <u>bringing of such action until sufficient United States Savings Bonds have</u>
- 14 accumulated in the State Treasurer's custody to justify the expense of
- 15 such proceedings.
- 16 (3) If no person files a claim or appears at the hearing to
- 17 substantiate a claim or the court determines that a claimant is not
- 18 entitled to the property claimed by such claimant, then the court, if
- 19 satisfied by evidence that the State Treasurer has complied with the act
- 20 and all other applicable laws of this state, shall enter a judgment that
- 21 <u>such United States Savings Bonds have escheated to the state.</u>
- 22 (4) The State Treasurer shall redeem such United States Savings
- 23 Bonds and the proceeds from such redemption shall be deposited as
- 24 provided in section 69-1317.
- 25 (b) Any person making a claim for such United States Savings Bonds
- 26 <u>under subsection (a) of this section or for the proceeds from such bonds</u>
- 27 <u>shall file a claim in accordance with the Uniform Disposition of</u>
- 28 Unclaimed Property Act. Upon providing sufficient proof of the validity
- 29 of such person's claim, the State Treasurer shall pay such claim in
- 30 accordance with the act.
