- 1 A BILL FOR AN ACT relating to state agencies; to amend section 81-118.01,
- 2 Reissue Revised Statutes of Nebraska; to except the University of
- 3 Nebraska and the Nebraska State College System from participation in
- 4 certain state contracts regarding electronic payments as prescribed;
- 5 and to repeal the original section.
- 6 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. Section 81-118.01, Reissue Revised Statutes of Nebraska,
- 2 is amended to read:
- 3 81-118.01 (1) Any state official or state agency may accept credit
- 4 cards, charge cards, or debit cards, whether presented in person or
- 5 electronically, or electronic funds transfers as a method of cash payment
- 6 of any tax, levy, excise, duty, custom, toll, interest, penalty, fine,
- 7 license, fee, or assessment of whatever kind or nature, whether general
- 8 or special, as provided by section 77-1702.
- 9 (2) The total amount of such taxes, levies, excises, duties,
- 10 customs, tolls, interest, penalties, fines, licenses, fees, or
- 11 assessments of whatever kind or nature, whether general or special, paid
- 12 for by credit card, charge card, debit card, or electronic funds transfer
- 13 shall be collected by the state official or state agency.
- 14 (3) Any state official or state agency operating a facility in a
- 15 proprietary capacity may choose to accept credit cards, charge cards, or
- 16 debit cards, whether presented in person or electronically, or electronic
- 17 funds transfers as a means of cash payment, and may adjust the price for
- 18 services to reflect the handling and payment costs.
- 19 (4) The state official or state agency shall obtain, for each
- 20 transaction, authorization for use of any credit card, charge card, or
- 21 debit card used pursuant to this section from the financial institution,
- 22 vending service company, credit card or charge card company, or third-
- 23 party merchant bank providing such service.
- 24 (5) Except with respect to the University of Nebraska and the
- 25 <u>Nebraska State College System, the</u> types of credit cards, charge
- 26 cards, or debit cards accepted and the payment services provided for any
- 27 state official or state agency shall be determined by the State Treasurer
- 28 and the Director of Administrative Services with the advice of the
- 29 committee convened pursuant to subsection (5) of section 13-609. The
- 30 State Treasurer and the director shall contract with one or more credit
- 31 card, charge card, or debit card companies or third-party merchant banks

for services on behalf of the state and those counties, cities, and political subdivisions that choose to participate in the state contract for such services. The University of Nebraska and the Nebraska State College System may choose to participate in the state contract for such services. Any negotiated discount, processing, or transaction fee imposed by a credit card, charge card, or debit card company or third-party

7 merchant bank shall be considered, for purposes of this section, as an

8 administrative expense.

- 9 (6) A state official or state agency obtaining, for each 10 transaction, authorization for use of any credit card or charge card used pursuant to this section may, but is not required to, impose a surcharge 11 or convenience fee upon the person making a payment by credit card or 12 13 charge card so as to wholly or partially offset the amount of any 14 discount or administrative fees charged to the state agency, but the surcharge or convenience fee shall not exceed the surcharge 15 16 convenience fee imposed by the credit card or charge card companies or 17 third-party merchant banks which have contracted under subsection (5) of this section. The surcharge or convenience fee shall be applied only when 18 19 allowed by the operating rules and regulations of the credit card or charge card involved or when authorized in writing by the credit card or 20 charge card company involved. When a person elects to make a payment to a 21 state agency by credit card or charge card and such a surcharge or 22 convenience fee is imposed, the payment of such surcharge or convenience 23 24 fee shall be deemed voluntary by such person and shall be in no case 25 refundable. If a payment is made electronically by credit card, charge card, debit card, or electronic funds transfer as part of a system for 26 providing or retrieving information electronically, the state official or 27 28 state agency shall be authorized but not required to impose an additional surcharge or convenience fee upon the person making a payment. 29
- 30 (7) For purposes of this section, electronic funds transfer means 31 the movement of funds by nonpaper means, usually through a payment
