Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

This bill authorizes the Department of Health and Human Services to issue a commemorative certificate for a nonviable birth prior to the twentieth week of gestation during a pregnancy that has been verified by a health care practitioner. The Department would issue the certificate when provided with a letter certifying the nonviable birth to the patient. The nonviable birth would not be registered. The certificate would have no legal effect. The Department is required to charge a fee not to exceed the cost for issuing the certificate.

The commemorative certificate is not to be registered and has no legal effect. Once the certificate is issued, the Department has no further responsibilities or obligations, so nothing would need to be permanently retained unlike other vital records. The design of the certificate can be handled within existing resources. Cost of staff time to verify the letters from health care professionals and print and send the certificates would be nominal and covered by the fee authorized in the bill. The staffing costs in the Department of Health and Human Services fiscal note are existing staff and represents the time that would be allocated to this activity.

Explanation of Estimate:

AM 1995 amends LB 1040 to provide "commemorative certificate" a distinct definition from "certificate" within the Vital Statistics Act. It replaces instances of "certificate of nonviable birth" with "commemorative certificate of nonviable birth." Additionally, it strikes "certifying" and replaces it with "verifying." "Certificate" and "certification" are defined terms within the Vital Statistics Act that result in record retention requirements. AM 1995 seeks to avoid a requirement for the Department to retain vital record information with regard to nonviable birth requests.

AM 1995 would preclude the need for an event creation within the Department's vital records system. However, a manual process to fulfill requests for commemorative certificates would require additional staff time. The amount would be largely dependent on consumer demand. Neither LB 1040 nor AM 1995 prevent retroactive requests for commemorative certificates for nonviable births taking place prior to the bill's enactment. A gestational lower bound is not explicitly provided in LB 1040 or AM 1995. This may result in a greater proportion of miscarriages being verified than in Florida, which is the only state to date with similar legislation already enacted. The Department estimates issuing approximately 120 certificates in FY19 and 240 in FY20. The Department would be authorized to set fees for providing commemorative certificates. This fiscal note assumes a fee equivalent to the \$17 charged for a certificate of birth resulting in stillbirth.
