Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

This bill would prohibit counties, local governments, and certain state entities from spending legislative appropriations under certain conditions.

The Supreme Court states that this bill would eliminate nongovernmental funding sources. As a result, grant-funded programs would be terminated. The Supreme Court notes that from CY2015 through CY2017, they have been awarded approximately \$1.9 million from nongovernmental grants. The Court also notes that they expect to receive approximately \$1.0 million in additional grant funds through CY2020. They also note that revenue such as registration fees or court fees was not considered in their response. See the Court's response attached for additional details not included in this fiscal note.
