Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB 264 amended Nebraska Revised Statutes Section 48-721 regarding requirements for state boiler inspectors.

The new language of the bill specifies that the state boiler inspector shall hold an AI Commission from the National Board of Boiler and Pressure Vessel Inspectors. An "AI Commission" is a National Board Authorized Inspector Commission and is issued to, "individuals who have been qualified to perform inspections related to installation and in-service, that is, the jurisdictionally required periodic inspections of boilers and pressure vessels that are in operation."

In addition, the state boiler inspector is also required to either have or acquire within 18 months of appointment, a "B" and "R" endorsement. A "B" endorsement is for Authorized Inspector Supervisors. The "R" endorsement refers to a Repair Inspector.

The bill also adds language regarding the requirements for deputy inspectors that they shall hold either an "IS Commission" or and "AI Commission." An "IS Commission" is the In-service Commission.

The Department of Labor estimates no fiscal impact as result of the provisions of LB 264.

We agree with the Department of Labor's estimate of fiscal impact.
