**Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.**

This bill requires the Department of Health and Human Services to create a list of perinatal hospice programs. The list of programs and a general description of the health care services available from the programs would be posted on their website.

The department estimates that in FY 2018, two percent of a Community Health Nurse's time would be needed to gather the information for the website posting. Since this is not an allowable activity under the department's federal funds, the nurse's time would be allocated to General Funds. The one-time cost would be \$1,723.

**Explanation of Estimate:**

LB 506 would require the Department to compile a geographic listing of perinatal hospice programs available in Nebraska and nationally. This information, along with services provided, hours of operation, and contact information would be posted on the Department's website. The bill would require the Department to develop an informational support sheet in English and Spanish summarizing perinatal hospice programs in Nebraska and nationally.

The Department estimates it would require 0.02 FTE Community Health Nurse/Senior in the Division of Public Health Lifespan Services unit during FY 2017-18 to complete the requirements of LB 506. The Lifespan Services unit is completely federally funded. Because the requirements of LB 506 would not be allowable under the unit's federal grant funding, this note assumes a General Fund expense to the Department.

LB 506 requires the website and information support sheet be available within 90 days of the effective date of the act. Because the bill does not contain an emergency clause, the Department assumes an effective date of October 1, 2017, and completion of requirements in Sec. 4 prior to January 1, 2018.
