LB 900 updates references to certain federal provisions related to motor vehicles. These changes have no fiscal impact. The bill also increases the amount that may be imposed as a civil penalty by the Superintendent of Law Enforcement and Public Safety against motor carriers transporting persons or property in interstate commerce for various violations. The State Patrol indicates the increase in the fine for violations of subsections (2), (3) and (4) of Section 75-369.03 may result in a minimal, if any, increase in revenue because violations are rarely cited. Any increase in revenue accrues to the county where the violation occurs, for use by the public schools.
