- 1 A BILL FOR AN ACT relating to highways and bridges; to amend section
- 2 39-1811, Reissue Revised Statutes of Nebraska; to change provisions
- 3 relating to mowing of weeds as prescribed; to harmonize provisions;
- 4 and to repeal the original section.
- 5 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. Section 39-1811, Reissue Revised Statutes of Nebraska, is
- 2 amended to read:
- 3 39-1811 (1) It shall be the duty of the landowners in this state to
- 4 mow all weeds that can be mowed with the ordinary farm mower to the
- 5 middle of all public roads and drainage ditches running along their lands
- 6 at least twice each year, namely, sometime in July for the first time and
- 7 sometime in September for the second time before July 15, for the first
- 8 time and sometime in August for the second time.
- 9 (2) This section shall not restrict landowners, a county, or a
- 10 township from management of (a) roadside vegetation on road shoulders or
- 11 <u>of sight distances at intersections and entrances at any time of the year</u>
- 12 <u>or (b) snow control mowing as may be necessary.</u>
- 13 (3) Except as provided in subsection (2) of this section, no person
- 14 <u>employed by or under contract with a county or township to mow roadside</u>
- 15 ditches shall do such mowing before July 1 of any year.
- 16 (4) (2) Whenever a landowner, referred to in subsections (1) and (5)
- 17 (3) of this section, neglects to mow the weeds as provided in this
- 18 section, it shall be the duty of the county board on complaint of any
- 19 resident of the county to cause the weeds to be mowed or otherwise
- 20 destroyed on neglected portions of roads or ditches complained of.
- 21 (5) (3) The county board shall cause to be ascertained and recorded
- 22 an accurate account of the cost of mowing or destroying such weeds, as
- 23 referred to in subsections (1) and (4) (2) of this section, in such
- 24 places, specifying, in such statement or account of costs, the
- 25 description of the land abutting upon each side of the highway where such
- 26 weeds were mowed or destroyed, and, if known, the name of the owner of
- 27 such abutting land. The board shall file such statement with the county
- 28 clerk, together with a description of the lands abutting on each side of
- 29 the road where such expenses were incurred, and the county board, at the
- 30 time of the annual tax levy made upon lands and property of the county,
- 31 may, if it desires, assess such cost upon such abutting land, giving such

1 landowner due notice of such proposed assessment and reasonable

- 2 opportunity to be heard concerning the proposed assessment before the
- 3 same is finally made.
