1 A BILL FOR AN ACT relating to firearms; to amend sections 28-1351 and 2 28-1354, Reissue Revised Statutes of Nebraska, and sections 28-101, 3 28-1201, and 43-2,129, Revised Statutes Supplement, 2017; to create 4 the offense of possession of a firearm by a prohibited juvenile offender and provide a process to reinstate the right to possess a 5 firearm by such an offender; to create a duty for the court under 6 7 the Nebraska Juvenile Code; to harmonize provisions; and to repeal 8 the original sections.

9 Be it enacted by the people of the State of Nebraska,

Section 1. Section 28-101, Revised Statutes Supplement, 2017, is
 amended to read:

10 (1) Firearm means any weapon which is designed to or may readily be
11 converted to expel any projectile by the action of an explosive or frame
12 or receiver of any such weapon;

(2) Fugitive from justice means any person who has fled or is
fleeing from any peace officer to avoid prosecution or incarceration for
a felony;

16 (3) Handgun means any firearm with a barrel less than sixteen inches
17 in length or any firearm designed to be held and fired by the use of a
18 single hand;

19 (4) Juvenile means any person under the age of eighteen years;

20 (5) Knife means:

(a) Any dagger, dirk, knife, or stiletto with a blade over three and
one-half inches in length and which, in the manner it is used or intended
to be used, is capable of producing death or serious bodily injury; or

(b) Any other dangerous instrument which is capable of inflicting
cutting, stabbing, or tearing wounds and which, in the manner it is used
or intended to be used, is capable of producing death or serious bodily
injury;

(6) Knuckles and brass or iron knuckles means any instrument that
consists of finger rings or guards made of a hard substance and that is
designed, made, or adapted for the purpose of inflicting serious bodily
injury or death by striking a person with a fist enclosed in the

1 knuckles;

2 (7) Machine gun means any firearm, whatever its size and usual
3 designation, that shoots automatically more than one shot, without manual
4 reloading, by a single function of the trigger;

5 (8) School means a public, private, denominational, or parochial 6 elementary, vocational, or secondary school, a private postsecondary 7 career school as defined in section 85-1603, a community college, a 8 public or private college, a junior college, or a university;

9 (9) Short rifle means a rifle having a barrel less than sixteen 10 inches long or an overall length of less than twenty-six inches; and

(10) Short shotgun means a shotgun having a barrel or barrels less
 than eighteen inches long or an overall length of less than twenty-six
 inches.

Sec. 3. (1) Except as provided in subsections (3) and (4) of this section, a person under the age of twenty-five years who knowingly possesses a firearm commits the offense of possession of a firearm by a prohibited juvenile offender if he or she has previously been adjudicated an offender in juvenile court for an act which would constitute a felony or an act which would constitute a misdemeanor crime of domestic violence.

(2) Possession of a firearm by a prohibited juvenile offender is a
 Class IV felony for a first offense and a Class IIIA felony for a second
 or subsequent offense.

(3) Subsection (1) of this section does not apply to the possession
of firearms by members of the armed forces of the United States, active
or reserve, National Guard of this state, or Reserve Officers Training
Corps or peace officers or other duly authorized law enforcement officers
when on duty or training.

(4)(a) Prior to reaching the age of twenty-five years, a person
 subject to the prohibition of subsection (1) of this section may file a
 petition for exemption from such prohibition and thereby have his or her

1	right to possess a firearm reinstated. A petitioner who is younger than
2	nineteen years of age shall petition the juvenile court in which he or
3	she was adjudicated for the underlying offense. A petitioner who is
4	nineteen years of age or older shall petition the district court in the
5	<u>county in which he or she resides.</u>
6	<u>(b) In determining whether to grant a petition filed under</u>
7	subdivision (4)(a) of this section, the court shall consider:
8	<u>(i) The behavior of the person after the underlying adjudication;</u>
9	<u>(ii) The likelihood that the person will engage in further criminal</u>
10	activity; and
11	(iii) Any other information the court considers relevant.
12	<u>(c) The court may grant a petition filed under subdivision (4)(a) of</u>
13	this section and issue an order exempting the person from the prohibition
14	of subsection (1) of this section when in the opinion of the court the
15	order will be in the best interests of the person and consistent with the
16	<u>public welfare.</u>
17	<u>(5) The fact that a person subject to the prohibition under</u>
18	subsection (1) of this section has reached the age of twenty-five or that
19	<u>a court has granted a petition under subdivision (4)(a) of this section</u>
20	shall not be construed to mean that such adjudication has been set aside.
21	Nothing in this section shall be construed to authorize the setting aside
22	of such an adjudication or conviction except as otherwise provided by
23	<u>law.</u>
24	<u>(6) For purposes of this section, misdemeanor crime of domestic</u>
25	violence has the same meaning as in section 28-1206.

(a) Incurred or contracted in gambling activity which was in violation of federal law or the law of the state or which is unenforceable under state or federal law in whole or in part as to principal or interest because of the laws relating to usury; or

(b) Which was incurred in connection with the business of gambling in violation of federal law or the law of the state or the business of lending money or a thing of value at a rate usurious under state law if the usurious rate is at least twice the enforceable rate.

Sec. 6. (1) When the petition alleges the juvenile committed an act which would constitute a felony or an act which would constitute a misdemeanor crime of domestic violence, the court shall explain the specific legal consequences that an adjudication for such an act will have on the juvenile's right to possess a firearm. The court shall provide such explanation at the earlier of:

(a) The juvenile's first court appearance or, if the juvenile is not
 present in the court at the time of the first appearance, by written
 notice sent by regular mail to the juvenile's last-known address; or
