- 1 A BILL FOR AN ACT relating to child abuse and neglect; to amend section
- 2 28-713, Reissue Revised Statutes of Nebraska; to change duties of
- 3 the Department of Health and Human Services as prescribed; and to
- 4 repeal the original section.
- 5 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 28-713, Reissue Revised Statutes of Nebraska, is

- 2 amended to read:
- 3 28-713 Unless an intake is assigned to alternative response, upon
- 4 the receipt of a call reporting child abuse and neglect as required by
- 5 section 28-711:
- 6 (1) It is the duty of the law enforcement agency to investigate the
- 7 report, to take immediate steps to protect the child, and to institute
- 8 legal proceedings if appropriate. In situations of alleged out-of-home
- 9 child abuse or neglect if the person or persons to be notified have not
- 10 already been notified and the person to be notified is not the subject of
- 11 the report of child abuse or neglect, the law enforcement agency shall
- 12 immediately notify the person or persons having custody of each child who
- 13 has allegedly been abused or neglected that such report of alleged child
- 14 abuse or neglect has been made and shall provide such person or persons
- 15 with information of the nature of the alleged child abuse or neglect. The
- 16 law enforcement agency may request assistance from the department during
- 17 the investigation and shall, by the next working day, notify either the
- 18 hotline or the department of receipt of the report, including whether or
- 19 not an investigation is being undertaken by the law enforcement agency. A
- 20 copy of all reports, whether or not an investigation is being undertaken,
- 21 shall be provided to the department;
- 22 (2) In situations of alleged out-of-home child abuse or neglect if
- 23 the person or persons to be notified have not already been notified and
- 24 the person to be notified is not the subject of the report of child abuse
- 25 or neglect, the department shall immediately notify the person or persons
- 26 having custody of each child who has allegedly been abused or neglected
- 27 that such report of alleged child abuse or neglect has been made and
- 28 shall provide such person or persons with information of the nature of
- 29 the alleged child abuse or neglect and any other information that the
- 30 department deems necessary. The department shall investigate for the
- 31 purpose of assessing each report of child abuse or neglect to determine

- 1 the risk of harm to the child involved. The department shall also provide
- 2 such social services as are necessary and appropriate under the
- 3 circumstances to protect and assist the child and to preserve the family,
- 4 without regard to whether the department or law enforcement is
- 5 investigating the allegation;
- 6 (3) The department may make a request for further assistance from
- 7 the appropriate law enforcement agency or take such legal action as may
- 8 be appropriate under the circumstances;
- 9 (4) The department shall, by the next working day after receiving a
- 10 report of child abuse or neglect under subdivision (1) of this section,
- 11 make a written report or a summary on forms provided by the department to
- 12 the proper law enforcement agency in the county and enter in the tracking
- 13 system of child protection cases maintained pursuant to section 28-715
- 14 all reports of child abuse or neglect opened for investigation and any
- 15 action taken; and
- 16 (5) The department shall, upon request, make available to the
- 17 appropriate investigating law enforcement agency and the county attorney
- 18 a copy of all reports relative to a case of suspected child abuse or
- 19 neglect.
