1 A BILL FOR AN ACT relating to schools; to amend sections 79-724 and 2 79-727, Reissue Revised Statutes of Nebraska; to change provisions 3 relating to the committee on Americanism; to eliminate a penalty; to 4 provide duties for the State Board of Education and the State 5 Department of Education; to harmonize provisions; and to repeal the original sections.

7 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 79-724, Reissue Revised Statutes of Nebraska, is 2 amended to read:

3 79-724 It is the responsibility of society to ensure that youth are 4 given the opportunity to become competent, responsible, patriotic, and civil citizens to ensure a An informed, loyal, just, and patriotic 5 citizenry is necessary to a strong, stable, just, and prosperous America. 6 7 Such a citizenry necessitates that every member thereof be fully <u>literate</u> about our acquainted with the nation's history, government, geography, 8 and economic system. The youth in our state should be committed to the 9 10 ideas and values of our country's democracy and the constitutional republic established by the people. Schools should help prepare our youth 11 to make informed and reasoned decisions for the public good. Civic 12 13 competence is necessary to sustain and improve our democratic way of life and must be taught in all public, private, denominational, and parochial 14 schools. A central role of schools is to impart civic knowledge and 15 skills that help our youth to see the relevance of a civic dimension for 16 17 their lives. Students should be made fully aware of the liberties, opportunities, and advantages of which we are possessed and the 18 19 sacrifices and struggles of those through whose efforts these benefits were gained and that he or she be in full accord with our form of 20 21 government and fully aware of the liberties, opportunities, and 22 advantages of which we are possessed and the sacrifices and struggles of 23 those through whose efforts these benefits were gained. Since youth is the time most susceptible to the acceptance of principles and doctrines 24 25 that will influence men and women throughout their lives, it is one of the first duties of our educational system to conduct its activities, 26 27 choose its textbooks, and arrange its curriculum in such a way that the 28 youth of our state become competent, responsible, patriotic, and civil American citizens the love of liberty, justice, democracy, and America 29 will be instilled in the hearts and minds of the youth of the state. 30

(1) Every school board of a school district shall, at the beginning

- 1 of each school year, appoint from its members a committee of three, to be
- 2 known as the committee on Americanism. The committee on Americanism
- 3 shall:
- 4 (a) Hold no fewer than three public meetings annually, at least one
- 5 where public testimony is accepted;
- 6 (b) Keep minutes of all meetings showing the time and place of the
- 7 meeting, which members were present and absent, and the substance and
- 8 details of all matters discussed;
- 9 (c) (a) Carefully examine and ensure that the social studies
- 10 <u>curriculum used in the district is aligned to the social studies</u>
- 11 standards adopted pursuant to section 79-760.01 and teaches and assesses
- 12 <u>foundational knowledge in civics, history, economics, financial literacy,</u>
- 13 <u>and geography;</u>
- 14 (d) Review and approve the social studies curriculum to ensure that
- 15 it adequately stresses , inspect, and approve all textbooks used in the
- 16 teaching of American history and civil government in the school. Such
- 17 textbooks shall adequately stress the services of the men and women who
- 18 achieved our national independence, established our constitutional
- 19 government, and preserved our union and is shall be so written to include
- 20 the incorporation of curriculum standards as set forth in sections 79-719
- 21 to 79-723 so contributions by ethnic groups as to develop a pride and
- 22 respect for our institutions and not be a mere recital of events and
- 23 dates;
- 24 (e) Ensure any curriculum that is recommended or approved by the
- 25 committee on Americanism is made readily accessible to the public and
- 26 <u>contains a reference to this section;</u>
- 27 (f) Ensure the district develops and utilizes formative, interim,
- 28 and summative assessments, including at a minimum, but not limited to,
- 29 <u>the one-hundred-question civics portion of the naturalization examination</u>
- 30 administered by United States Citizenship and Immigration Services to
- 31 determine student mastery of the social studies standards adopted

- 1 pursuant to section 79-760.01 administered no later than eighth grade and
- 2 eleventh grade, with the individual score from such examination for each
- 3 student reported to the parents or quardians of such student and the
- 4 aggregate scores for each school district reported annually to the
- 5 <u>department;</u>
- 6 (g) (b) Assure themselves as to the character of all teachers
- 7 employed and their knowledge and acceptance of the American form of
- 8 government; and
- 9 $\frac{\text{(h)}}{\text{(c)}}$ Take all such other steps as will assure the carrying out of
- 10 the provisions of this section and provide a report to the school board
- 11 regarding the committee's findings and recommendations.
- 12 (2) All <u>social studies</u> American history courses approved for grade
- 13 levels as provided by this section shall include and adequately stress
- 14 contributions of all ethnic groups (a) to the development and growth of
- 15 America into a great nation, (b) to art, music, education, medicine,
- 16 literature, science, politics, and government, and (c) to the war
- 17 services in all wars of this nation.
- 18 (3) All grades of all public, private, denominational, and parochial
- 19 schools, below the sixth grade, shall devote at least one hour per week
- 20 to exercises or teaching periods for the following purpose:
- 21 (a) The <u>discussion</u> recital of stories having to do with American
- 22 history or the deeds and exploits of American heroes;
- 23 (b) The <u>historical background, memorization, and</u> singing of
- 24 patriotic songs <u>such as</u> and the insistence that every pupil memorize the
- 25 Star-Spangled Banner and America the Beautiful; and
- 26 (c) The development of reverence for the flag and instruction as to
- 27 proper conduct in its presentation.
- 28 (4) In at least two of the three grades from the fifth grade to the
- 29 eighth grade in all public, private, denominational, and parochial
- 30 schools, <u>time</u> at least three periods per week shall be set aside <u>for</u> to
- 31 be devoted to the teaching of American history from the social studies

- 1 <u>curriculum approved textbooks</u>, <u>which shall be taught in such a way that</u>
- 2 all students are given the opportunity to become competent, responsible,
- 3 patriotic, and civil citizens who possess a deep understanding of the
- 4 United States Constitution and the Constitution of Nebraska and be
- 5 prepared to preserve, protect, and defend freedom and democracy in our
- 6 <u>nation and our world</u> as to make the course interesting and attractive and
- 7 to develop a love of country.
- 8 (5) In at least two <u>courses in</u> grades of every high school, <u>time</u> at
- 9 least three periods per week shall be devoted to the teaching of civics
- 10 and American history as outlined in the social studies standards adopted
- 11 <u>pursuant to section 79-760.01</u>, during which courses specific attention
- 12 shall be given to the following matters:
- 13 (a) The <u>Declaration of Independence, the United States Constitution</u>,
- 14 and the Constitution of Nebraska, and the structure and function of local
- 15 government in this state;
- 16 (b) The benefits and advantages of our form of government, and the
- 17 rights and responsibilities of citizenship in our government, and the
- 18 <u>dangers</u> and fallacies of forms of government that restrict individual
- 19 freedoms or possess antidemocratic ideals such as, but not limited to,
- 20 Nazism and communism; dangers and fallacies of Nazism, Communism, and
- 21 similar ideologies; and
- 22 (c) The duties of citizenship, including active participation in the
- 23 improvement of a citizen's community, state, country, and world and the
- 24 value and practice of civil discourse between opposing interests; and -
- 25 (d) The application of knowledge in civics, history, economics,
- 26 <u>financial literacy</u>, and geography in order to address meaningful issues
- 27 within our society.
- 28 (6) Appropriate patriotic exercises suitable to the occasion shall
- 29 be held under the direction of the superintendent in every public,
- 30 private, denominational, and parochial school on George Washington's
- 31 <u>birthday, Abraham Lincoln's birthday, Dr. Martin Luther King, Jr.'s</u>

- 1 birthday, American Indian Day, Flag Day, Memorial Day, Veterans Day, and
- 2 Thanksgiving Day, or on the day or week Lincoln's birthday, Washington's
- 3 birthday, Flag Day, Memorial Day, and Veterans Day, or on the day
- 4 preceding or following such holiday, if the school is in session.
- 5 (7) Every school board, the State Board of Education, and the
- 6 superintendent of each school district in the state shall be held
- 7 directly responsible in the order named for carrying out this section,
- 8 and neglect thereof by any employee or appointed official shall be
- 9 considered a dereliction of duty and may be considered a cause for
- 10 dismissal.
- 11 Sec. 2. Section 79-727, Reissue Revised Statutes of Nebraska, is
- 12 amended to read:
- 13 79-727 The State Board of Education shall adopt and promulgate
- 14 rules and regulations to carry out the provisions of sections 79-724
- 15 through 79-726. The State Department of Education shall ensure that all
- 16 requirements of such sections and such rules and regulations are carried
- 17 out by each school district. Any person violating the provisions of
- 18 sections 79-724 to 79-726 is quilty of a Class III misdemeanor.
- 19 Sec. 3. Original sections 79-724 and 79-727, Reissue Revised
- 20 Statutes of Nebraska, are repealed.
