1 Section 1. Section 15-1202, Reissue Revised Statutes of Nebraska, is

- 3 15-1202 (1) The party appealing shall within thirty days after the
- 4 date of the order or decision complained of (a) file a notice of appeal
- 5 with the city clerk specifying the parties taking the appeal and the
- 6 order or decision appealed from and serve a copy of the notice upon the
- 7 city attorney and (b) deposit the fees and bond or undertaking required
- 8 pursuant to subsection (2) of this section or file an affidavit pursuant
- 9 to subsection (3) of this section. The notice of appeal shall serve as a
- 10 praecipe for a transcript.
- 11 (2) Except as provided in subsection (3) of this section, the
- 12 appellant shall:
- 13 (a) Deposit with the city clerk a docket fee in the amount of the
- 14 filing fee in district court for cases originally commenced in district
- 15 court;
- 16 (b) Deposit with the city clerk a cash bond or undertaking with at
- 17 least one good and sufficient surety approved by the city clerk, in the
- 18 amount of two hundred dollars, on condition that the appellant will
- 19 satisfy any judgment and costs that may be adjudged against him or her;
- 20 and
- 21 (c) Deposit with the city clerk the fees for the preparation of a
- 22 certified and complete transcript of the proceedings of the city relating
- 23 to the order or decision appealed.
- 24 (3)(a) An appellant may file with the city clerk an affidavit
- 25 alleging that the appellant is indigent. The filing of such an affidavit
- 26 shall relieve the appellant of the duty to deposit any fee, bond, or
- 27 undertaking required by subsection (2) of this section as a condition for
- 28 the preparation of the transcript or the perfecting of the appeal by the
- 29 appellant subject to the determination of the court as provided in
- 30 section 15-1204. In conjunction with the filing of the petition for
- 31 appeal as provided for in section 15-1204, the appellant shall file a

- 1 copy of the affidavit alleging his or her indigency and the district
- 2 court shall rule upon the issue of indigency prior to the consideration
- 3 of any other matter relating to the appeal as provided in section
- 4 15-1204.
- 5 (b) An appellant determined to be indigent under this subsection
- 6 shall not be required to deposit any fee, bond, or undertaking required
- 7 by subsection (2) of this section. For purposes of this section, indigent
- 8 means the inability to financially pursue the appeal without prejudicing
- 9 the appellant's ability to provide economic necessities for the appellant
- 10 or the appellant's family.
- 11 (c) An appellant determined not to be indigent shall, within thirty
- 12 days after the determination, deposit with the city clerk the fees and
- 13 bond or undertaking required by subsection (2) of this section. The
- 14 appeal shall not proceed further until the city clerk notifies the court
- 15 that the appropriate deposit has been made.

- 15 the preservation of an accurate record. Such hearings shall not include
- 16 trials before a jury. Hearings conducted in this manner shall be
- 17 consistent with the public's access to the courts.
