1 Section 1. Section 81-2,155, Reissue Revised Statutes of Nebraska,

- 2 is amended to read:
- 3 81-2,155 It shall be unlawful for any person, firm, corporation or
- 4 its agents or representatives to sell, offer or expose for sale, or
- 5 falsely mark or tag, within the State of Nebraska, any seed corn as
- 6 hybrid unless it is answers to the following definition: Hybrid seed corn
- 7 shall be seed of the first generation of a cross involving two, three, or
- 8 four different inbred lines of corn or their combinations., and shall be
- 9 restricted to seed of single crosses, three-way crosses, and double
- 10 crosses, these in turn being defined as follows:
- 11 (1) Single cross: The first generation of a hybrid between two
- 12 inbred lines;
- 13 (2) Three-way cross: The first generation of a hybrid between a
- 14 single cross and an inbred line;
- 15 (3) Double cross: The first generation of a hybrid between two
- 16 single crosses.
- 17 Sec. 2. Section 81-2,156, Reissue Revised Statutes of Nebraska, is
- 18 amended to read:
- 19 81-2,156 The cross mentioned in section 81-2,155 shall be produced
- 20 by cross fertilization, performed by a method of proper isolation in time
- 21 or distance and controlled either by hand, or by detasseling under
- 22 <u>isolation</u> at the proper <u>times</u>, or by utilizing male sterility systems
- 23 time.
- Sec. 3. Section 81-2,157, Reissue Revised Statutes of Nebraska, is
- 25 amended to read:
- 26 81-2,157 (1) Any person who violates any of the provisions of
- 27 sections 81-2,155 and 81-2,156 shall be quilty of a Class III misdemeanor
- 28 Every violation of the provisions of sections 81-2,155 and 81-2,156 shall
- 29 be a Class III misdemeanor. The Department of Agriculture, through its
- 30 duly authorized agent or agents, shall report violations of said sections
- 31 to the proper county attorney or to the Attorney General for prosecution.

- 1 (2) In addition to the criminal penalty provided under subsection
- 2 (1) of this section, a restraining order or a temporary, permanent, or
- 3 mandatory injunction may be imposed against any person violating or
- 4 threatening to violate any of the provisions of sections 81-2,155 and
- 5 81-2,156 in order to ensure compliance with such sections. The district
- 6 court of the county where the violation is occurring or is about to occur
- 7 shall have jurisdiction to grant such relief upon good cause shown.
- 8 Relief may be granted notwithstanding the existence of any other remedy
- 9 at law and shall be granted without bond.
- 10 (3) It shall be the duty of the Attorney General or the county
- 11 <u>attorney of the county in which violations of sections 81-2,155 and</u>
- 12 81-2,156 are occurring or are about to occur, when notified of such
- 13 violations or threatened violations by the Director of Agriculture, to
- 14 pursue appropriate action as provided in subsections (1) and (2) of this
- 15 section without delay.
- 16 Sec. 4. Original sections 81-2,155, 81-2,156, and 81-2,157, Reissue
- 17 Revised Statutes of Nebraska, are repealed.
