- 1 A BILL FOR AN ACT relating to the Nebraska Workers' Compensation Act; to
- 2 amend section 48-1,110, Revised Statutes Cumulative Supplement,
- 3 2016; to provide for an evidence-based drug formulary as prescribed;
- 4 to harmonize provisions; and to repeal the original section.
- 5 Be it enacted by the people of the State of Nebraska,

- Section 1. (1) The Nebraska Workers' Compensation Court shall adopt
- 2 <u>an evidence-based drug formulary consisting of prescription drugs listed</u>
- 3 <u>in Schedules II, III, IV, and V of section 28-405. Such formulary shall</u>
- 4 apply to prescription drugs that are prescribed and dispensed for
- 5 outpatient use in connection with workers' compensation claims with a
- 6 <u>date of injury on or after January 1, 2018.</u>
- 7 (2) A prescription drug that is included in the formulary adopted by
- 8 the compensation court and recommended in such formulary is presumed to
- 9 be reasonable under subdivision (1)(a) of section 48-120 and may be
- 10 prescribed and dispensed without obtaining prior authorization from the
- 11 workers' compensation insurer, risk management pool, or self-insured
- 12 <u>employer.</u>
- 13 (3) A prescription drug that is not included in the formulary
- 14 <u>adopted by the compensation court or that is included but not recommended</u>
- in such formulary is presumed to be reasonable under subdivision (1)(a)
- 16 of section 48-120 if prior authorization for such drug is obtained from
- 17 <u>the workers' compensation insurer, risk management pool, or self-insured</u>
- 18 employer.
- 19 (4) Any party may request a finding by an independent medical
- 20 <u>examiner pursuant to section 48-134.01 if (a) the workers' compensation</u>
- 21 insurer, risk management pool, or self-insured employer denies payment
- 22 for a prescription drug that is not included in the formulary adopted by
- 23 the compensation court or that is included but not recommended in such
- 24 formulary or (b) the workers' compensation insurer, risk management pool,
- 25 or self-insured employer denies prior authorization for a prescription
- 26 <u>drug that is not included in the formulary adopted by the compensation</u>
- 27 <u>court or that is included but not recommended in such formulary.</u>
- 28 <u>(5) The compensation court may adopt and promulgate rules and</u>
- 29 <u>regulations necessary to implement this section.</u>
