- 2 23-1822, 33-138, 33-139, and 48-135, Reissue Revised Statutes of
- 3 Nebraska; to change provisions relating to the payment of fees and
- 4 costs associated with grand juries and the deaths of incarcerated
- 5 persons; to harmonize provisions; and to repeal the original
- 6 sections.
- 7 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 23-1822, Reissue Revised Statutes of Nebraska, is

2 amended to read:

3 23-1822 In each instance when the county coroner is given notice in accordance with section 23-1821 or when a grand jury is required to be 4 5 called pursuant to subsection (4) of section 29-1401, the coroner or coroner's physician shall perform examinations, tests an examination, a 6 7 test, or an autopsy as he or she may deem necessary to establish, by a reasonable degree of medical certainty, the cause or causes of death and 8 9 shall thereafter certify the cause or causes of death to the presiding judge of the district court. All costs of the examinations, tests, and 10 autopsy shall be paid by the county in which the person died, except that 11 when the person died while serving a sentence in a state correctional 12 institution, the costs shall be paid by the State of Nebraska. 13

Sec. 2. Section 33-138, Reissue Revised Statutes of Nebraska, is amended to read:

16 33-138 (1) Each member of a grand or petit jury in a district court 17 or county court shall receive for his or her services thirty dollars for each day employed in the discharge of his or her duties prior to January 18 1, 1994, and thirty-five dollars for each such day on or after such date 19 and mileage at the rate provided in section 81-1176 for each mile 20 necessarily traveled. No juror shall be entitled to pay for the days he 21 or she is voluntarily absent or excused from service by order of the 22 court. No juror shall be entitled to pay for nonjudicial days unless 23 24 actually employed in the discharge of his or her duties as a juror on 25 such days.

- (2) In the event that any temporary release from service, other than
  that obtained by the request of a juror, shall occasion an extra trip or
  trips to and from the residence of any juror or jurors the court may, by
  special order, allow mileage for such extra trip or trips.
- 30 (3) Payment of jurors for service in the district and county courts
  31 shall be made by the county, except that in a case before a grand jury

- 4 (4) A juror may voluntarily waive payment under this section for his
- 5 or her service as a juror.
- 6 Sec. 3. Section 33-139, Reissue Revised Statutes of Nebraska, is
- 7 amended to read:
- 8 33-139 Witnesses before the district court and the county court,
- 9 except the Small Claims Court, and the grand jury shall receive twenty
- 10 dollars, and witnesses before the Small Claims Court shall receive eight
- 11 dollars, for each day actually employed in attendance on the court or
- 12 grand jury, and if the witness shall reside more than one mile from the
- 13 courthouse or place where the court is held, he or she shall receive
- 14 mileage at the rate provided in section 81-1176 for state employees for
- each mile necessarily traveled. Such compensation shall be paid by the
- 16 county, except that in a case before a grand jury involving the death of
- 17 <u>an inmate who died while serving a sentence in a state correctional</u>
- 18 institution, witness compensation shall be paid by the State of Nebraska.
- 19 Sec. 4. Section 48-135, Reissue Revised Statutes of Nebraska, is
- 20 amended to read:
- 21 48-135 Except as provided in <u>sections 23-1822 and</u> <del>section</del> 23-1824,
- 22 in all death claims, where the cause of death is obscure or disputed, any
- 23 interested party may require an autopsy, the cost of such autopsy to be
- 24 borne by the party demanding the same.
- 25 Sec. 5. Original sections 23-1822, 33-138, 33-139, and 48-135,
- 26 Reissue Revised Statutes of Nebraska, are repealed.
