## **LEGISLATIVE BILL 470**

Introduced by Larson, 40.

1 A BILL FOR AN ACT relating to gambling; to amend sections 9-607 and 2 9-646.01, Reissue Revised Statutes of Nebraska, and section 9-601, 3 Revised Statutes Cumulative Supplement, 2016; to redefine a term; to 4 change the manner of play of keno as prescribed; to change provisions relating to keno tickets; to require reasonable measures 5 6 by lottery operators using electronic tickets; to provide for 7 authorization of methods of payment for participation in gaming 8 activities under the Nebraska County and City Lottery Act as 9 prescribed; to harmonize provisions; and to repeal the original 10 sections.

11 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. Section 9-601, Revised Statutes Cumulative Supplement,
- 2 2016, is amended to read:
- 3 9-601 Sections 9-601 to 9-653 and section 3 of this act shall be
- 4 known and may be cited as the Nebraska County and City Lottery Act.
- 5 Sec. 2. Section 9-607, Reissue Revised Statutes of Nebraska, is
- 6 amended to read:
- 7 9-607 (1) Lottery shall mean a gambling scheme in which:
- 8 (a) The players pay or agree to pay something of value for an
- 9 opportunity to win;
- (b) Winning opportunities are represented by tickets;
- 11 (c) Winners are solely determined by one of the following two
- 12 methods:
- 13 (i) By a random drawing of tickets differentiated by sequential
- 14 enumeration from a receptacle by hand whereby each ticket has an equal
- 15 chance of being chosen in the drawing; or
- (ii) By use of a game known as keno in which (A) a player selects up
- 17 to twenty numbers from a total of eighty numbers on a paper ticket or,
- 18 beginning January 1, 2018, an electronic ticket, (B) and a computer,
- 19 other electronic selection device, or electrically operated blower
- 20 machine, which is not player-activated, randomly selects up to twenty
- 21 numbers from the same pool of eighty numbers, and (C) the winning players
- 22 are determined by the correct matching of the numbers on the paper ticket
- 23 <u>or, beginning January 1, 2018, an electronic ticket</u> selected by the
- 24 players with the numbers randomly selected by the computer, other
- 25 electronic selection device, or electrically operated blower machine,
- 26 except that (A) no keno game shall permit or require player activation of
- 27 lottery equipment, each player shall be allowed to use a paper ticket for
- 28 selection of numbers upon request by the player beginning January 1,
- 29 2018, and <del>(B)</del> the random selection of numbers by the computer, other
- 30 electronic selection device, or electrically operated blower machine
- 31 shall not occur within four five minutes of the completion of the

- 1 previous selection of random numbers; and
- 2 (d) The holders of the winning paper or electronic tickets are to
- 3 receive cash or prizes redeemable for cash. Selection of a winner or
- 4 winners shall be predicated solely on chance.
- 5 (2) Lottery shall not include:
- 6 (a) Any gambling scheme which uses any mechanical gaming device,
- 7 computer gaming device, electronic gaming device, or video gaming device
- 8 which has the capability of awarding something of value, free games
- 9 redeemable for something of value, or tickets or stubs redeemable for
- 10 something of value;
- 11 (b) Any activity authorized or regulated under the Nebraska Bingo
- 12 Act, the Nebraska Lottery and Raffle Act, the Nebraska Pickle Card
- 13 Lottery Act, the Nebraska Small Lottery and Raffle Act, the State Lottery
- 14 Act, section 9-701, or Chapter 2, article 12; or
- 15 (c) Any activity prohibited under Chapter 28, article 11.
- 16 (3) Notwithstanding the requirement in subdivision (1)(c)(ii) of
- 17 this section that a player select up to twenty numbers, a player may
- 18 select more than twenty numbers on a paper ticket when a top or bottom,
- 19 left or right, edge, or way ticket is played. For a top or bottom ticket,
- 20 the player shall select all numbers from one through forty or all numbers
- 21 from forty-one through eighty. For a left or right ticket, the player
- 22 shall select all numbers ending in one through five or all numbers ending
- 23 in six through zero. For an edge ticket, the player shall select all of
- 24 the numbers comprising the outside edge of the ticket. For a way ticket,
- 25 the player shall select a combination of groups of numbers in multiple
- 26 ways on a single ticket.
- 27 (4) A county, city, or village conducting a keno lottery shall
- 28 designate the method of winning number selection to be used in the
- 29 lottery and submit such designation in writing to the department prior to
- 30 conducting a keno lottery. Only those methods of winning number selection
- 31 described in subdivision (1)(c)(ii) of this section shall be permitted,

- 1 and the method of winning number selection initially utilized may only be
- 2 changed once during that business day as set forth in the designation. A
- 3 county, city, or village shall not change the method or methods of
- 4 winning number selection filed with the department or allow it to be
- 5 changed once such initial designation has been made unless (a) otherwise
- 6 authorized in writing by the department based upon a written request from
- 7 the county, city, or village or (b) an emergency arises in which case a
- 8 ball draw method of number selection would be switched to a number
- 9 selection by a random number generator. An emergency situation shall be
- 10 reported by the county, city, or village to the department within twenty-
- 11 four hours of its occurrence.
- 12 Sec. 3. <u>Beginning January 1, 2018, a lottery operator operating a</u>
- 13 keno lottery which uses electronic tickets shall take reasonable measures
- 14 to prevent participation in the keno lottery by a person outside the
- 15 <u>licensed premises</u>. Such reasonable measures may include geofencing that
- 16 blocks access to participation outside of the licensed premises.
- 17 Sec. 4. Section 9-646.01, Reissue Revised Statutes of Nebraska, is
- 18 amended to read:
- 19 9-646.01 <u>(1) No person or licensee, or any employee or agent</u>
- 20 thereof, accepting wagers on a lottery conducted pursuant to the Nebraska
- 21 County and City Lottery Act shall extend credit from the gross proceeds
- 22 of a lottery to participants in the lottery for the purchase of lottery
- 23 tickets.
- 24 (2) Except as otherwise provided in subsection (3) of this section,
- 25 no No person shall purchase or be allowed to purchase any lottery ticket
- or make or be allowed to make any wager pursuant to the act unless he or
- 27 she pays for such ticket or wager with <u>United States currency or any</u>
- 28 method of payment representing United States currency cash.
- 29 (3) Beginning January 1, 2018, no person shall be allowed to
- 30 participate in keno unless he or she pays for such opportunity with cash
- 31 or cash equivalent including a debit or prepaid card but not including a

- 1 <u>credit card.</u> For purposes of this <u>subsection</u> section, cash shall mean
- 2 United States currency having the same face value as the price of the
- 3 ticket or wager.
