- 1 A BILL FOR AN ACT relating to telecommunications; to amend section
- 2 75-109.01, Revised Statutes Cumulative Supplement, 2016; to require
- 3 direct access to 911 emergency service from certain telephone
- 4 systems that use Internet protocol-enabled services; to provide for
- 5 Public Service Commission jurisdiction; and to repeal the original
- 6 section.
- 7 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. (1) Notwithstanding any other provision of law, a
- 2 telecommunications company or other business that owns or controls a
- 3 telephone system or an equivalent system that uses Internet protocol-
- 4 enabled service and provides outbound dialing capacity or access shall
- 5 <u>configure the telephone system or equivalent system to allow a person</u>
- 6 initiating a 911 call on the system to directly access 911 service by
- 7 dialing the digits 911 without an additional code, digit, prefix,
- 8 postfix, or trunk-access code.
- 9 (2) A telecommunications company or other business that provides
- 10 residential or business facilities, owns or controls a telephone system
- 11 <u>or an equivalent system that uses Internet protocol-enabled service, and</u>
- 12 provides outbound dialing capacity or access shall configure the
- 13 <u>telephone system or equivalent system to provide a notification to a</u>
- 14 <u>central location on the site of the residential or business facility when</u>
- 15 a person within the residential or business facility dials 911 if the
- 16 system is able to be configured to provide the notification without an
- 17 <u>improvement to the system's hardware. This subsection does not require a</u>
- 18 <u>telecommunications company or other business to have a person available</u>
- 19 <u>at the central location to receive a notification.</u>
- 20 (3) The Public Service Commission shall grant a one-year waiver of
- 21 the requirements under this section to such telecommunications company or
- 22 other business if:
- 23 <u>(a) The requirements would be unduly and unreasonably cost</u>
- 24 prohibitive for a telecommunications company or other business to comply
- 25 with; and
- 26 <u>(b) The telecommunications company or other business provides an</u>
- 27 affidavit not later than September 1 of each year stating:
- 28 <u>(i) The manufacturer and model number of the telephone system or</u>
- 29 <u>equivalent system that needs to be reprogrammed or replaced;</u>
- 30 (ii) That the telecommunications company or other business made a
- 31 good faith attempt to reprogram or replace the system; and

- 1 (iii) If the telephone system or equivalent system does not comply
- 2 with subsection (1) of this section, that the telecommunications company
- 3 or other business agrees to place an instructional sticker immediately
- 4 adjacent to each telephone that is accessed using the noncompliant system
- 5 <u>indicating that during the waiver period the telephone is unable to</u>
- 6 directly dial 911 and providing instructions for accessing 911 in case of
- 7 an emergency. The instructional sticker must be printed in at least
- 8 <u>sixteen-point boldface type in a contrasting color using a font that is</u>
- 9 <u>easily readable.</u>
- 10 (4) The commission may adopt and promulgate rules and regulations to
- 11 implement this section.

- 15 Public Service Commission shall have jurisdiction, as prescribed, over

- 19 (2) Grain pursuant to the Grain Dealer Act and the Grain Warehouse
- 20 Act and sections 89-1,104 to 89-1,108;
- 21 (3) Manufactured homes and recreational vehicles pursuant to the
- 22 Uniform Standard Code for Manufactured Homes and Recreational Vehicles;
- 23 (4) Modular housing units pursuant to the Nebraska Uniform Standards
- 24 for Modular Housing Units Act;
- 25 (5) Motor carrier registration and safety pursuant to sections
- 26 75-301 to 75-343, 75-369.03, 75-370, and 75-371;
- 27 (6) Pipeline carriers and rights-of-way pursuant to the Major Oil
- 28 Pipeline Siting Act, the State Natural Gas Regulation Act, and sections
- 29 75-501 to 75-503. If the provisions of Chapter 75 are inconsistent with
- 30 the provisions of the Major Oil Pipeline Siting Act, the provisions of
- 31 the Major Oil Pipeline Siting Act control;

- 3 (8) Telecommunications carriers pursuant to the Automatic Dialing-
- 4 Announcing Devices Act, the Emergency Telephone Communications Systems
- 5 Act, the Enhanced Wireless 911 Services Act, the Intrastate Pay-Per-Call
- 6 Regulation Act, the Nebraska Telecommunications Regulation Act, the
- 7 Nebraska Telecommunications Universal Service Fund Act, the
- 8 Telecommunications Relay System Act, the Telephone Consumer Slamming
- 9 Prevention Act, and sections 86-574 to 86-580 and section 1 of this act;

- 14 Regulation Act. If the provisions of Chapter 75 are inconsistent with the
- 15 provisions of the State Natural Gas Regulation Act, the provisions of the
- 16 State Natural Gas Regulation Act control.
