## **LEGISLATIVE BILL 628**

Introduced by Larson, 40.

- 1 A BILL FOR AN ACT relating to political subdivisions; to prohibit
- 2 ordinances and resolutions prohibiting short-term rentals of
- 3 residential property as prescribed.
- 4 Be it enacted by the people of the State of Nebraska,

1 Section 1. (1) For purposes of this section, short-term rental

- 2 means a residential property, including a single-family dwelling or a
- 3 unit in a condominium, cooperative, or time-share, that is rented wholly
- 4 or partly for a fee for a period not longer than thirty consecutive days.
- 5 (2) A city, village, or county may not adopt or enforce an ordinance
- 6 or resolution that expressly or effectively prohibits the use of a
- 7 property as a short-term rental. Except as provided by this section, a
- 8 city, village, or county may not adopt or enforce an ordinance or a
- 9 resolution that restricts the use of or otherwise regulates a short-term
- 10 <u>rental based on the short-term rental's classification, use, or</u>
- 11 <u>occupancy.</u>
- 12 (3) A city, village, or county may adopt or enforce an ordinance or
- 13 a resolution that specifically regulates property used as a short-term
- 14 rental only if the city, village, or county demonstrates that the primary
- 15 purpose of the ordinance or resolution is to protect the public's health
- 16 and safety. An ordinance or resolution authorized by this subsection
- 17 includes regulation:
- 18 (a) Addressing:
- (i) Fire and building codes;
- 20 (ii) Health and sanitation;
- 21 (iii) Traffic control; and
- 22 (iv) Solid or hazardous waste and pollution control; and
- 23 (b) Requiring the designation of an emergency contact for the
- 24 property.
- 25 (4) A city, village, or county may adopt or enforce an ordinance or
- 26 a resolution that limits or prohibits the use of a short-term rental only
- 27 <u>if the law limits or prohibits the use of a short-term rental for the</u>
- 28 purpose of:
- 29 <u>(a) Housing sex offenders;</u>
- 30 (b) Operating a structured sober living home or similar enterprise;
- 31 (c) Selling illegal drugs;

1 (d) Selling alcohol or another activity that requires a permit or

- 2 <u>license under the Nebraska Liquor Control Act; or</u>
- 3 (e) Operating as a sexually oriented business.
- 4 (5) A city, village, or county shall apply an ordinance or a
- 5 resolution regulating land use to a short-term rental in the same manner
- 6 <u>as another similar property</u>. An ordinance or a resolution described by
- 7 this subsection includes regulations governing:
- 8 (a) Residential use and other zoning matters;
- 9 <u>(b) Noise and other nuisances; and</u>
- (c) Property maintenance.
- 11 (6) This section may not be construed to affect regulations of a
- 12 private entity, including a homeowners association organized under the
- 13 <u>Condominium Property Act or the Nebraska Condominium Act.</u>
