- 2 Revised Statutes of Nebraska, and section 48-225, Revised Statutes
- 3 Cumulative Supplement, 2016; to define and redefine terms; to change
- 4 when a preference is required for certain government employment; and
- 5 to repeal the original section.
- 6 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 48-225, Revised Statutes Cumulative Supplement,

- 2 2016, is amended to read:
- 3 48-225 For purposes of sections 48-225 to 48-231:
- 4 (1) Servicemember means a person who serves on active duty in the
- 5 <u>armed forces of the United States except for training;</u>
- 6 (2) (1) Veteran means:
- 7 (a) A person who served full-time duty with military pay and
- 8 allowances in the armed forces of the United States, except for training
- 9 or for determining physical fitness, and was discharged or otherwise
- 10 separated with a characterization of honorable or general (under
- 11 honorable conditions); or
- 12 (b) The spouse of a veteran who has a one hundred percent permanent
- 13 disability as determined by the United States Department of Veterans
- 14 Affairs;
- 15 $\frac{(3)}{(2)}$ Full-time duty means duty during time of war or during a
- 16 period recognized by the United States Department of Veterans Affairs as
- 17 qualifying for veterans benefits administered by the department and that
- 18 such duty from January 31, 1955, to February 28, 1961, exceeded one
- 19 hundred eighty days unless lesser duty was the result of a service-
- 20 connected or service-aggravated disability;
- 21 (4) (3) Disabled veteran means an individual who has served on
- 22 active duty in the armed forces of the United States, has been discharged
- 23 or otherwise separated with a characterization of honorable or general
- 24 (under honorable conditions) therefrom, and has established the present
- 25 existence of a service-connected disability or is receiving compensation,
- 26 disability retirement benefits, or pension because of a public statute
- 27 administered by the United States Department of Veterans Affairs or a
- 28 military department; and
- 29 (5) (4) Preference eligible means any veteran as defined in this
- 30 section or the spouse of a servicemember as defined in this section,
- 31 except that for a spouse of a servicemember such preference is limited to

1 within one hundred eighty days of the servicemember's discharge or

- 2 <u>separation from service</u>.
- 3 Sec. 2. Section 48-226, Reissue Revised Statutes of Nebraska, is
- 4 amended to read:
- 5 48-226 A preference shall be given to preference eligibles seeking
- 6 employment with the State of Nebraska or its governmental subdivisions.
- 7 Such preference includes initial employment or a return to employment
- 8 with the State of Nebraska or its governmental subdivisions if
- 9 termination of previous employment was for other than disciplinary
- 10 <u>reasons.</u>
