- 1 A BILL FOR AN ACT relating to the Tax Equity and Educational 2 Opportunities Support Act; to amend section 79-1001, Revised 3 Statutes Cumulative Supplement, 2016, and sections 79-1003, 4 79-1007.11, and 79-1017.01, Revised Statutes Supplement, 2017; to 5 change provisions related to early childhood education aid; to 6 provide aid; to harmonize provisions; and to repeal the original sections. 7
- B Be it enacted by the people of the State of Nebraska,

- 4 plan allowance, and focus school and program allowance;
- 5 (2) Adjusted valuation means the assessed valuation of taxable
- 6 property of each local system in the state, adjusted pursuant to the
- 7 adjustment factors described in section 79-1016. Adjusted valuation means
- 8 the adjusted valuation for the property tax year ending during the school
- 9 fiscal year immediately preceding the school fiscal year in which the aid
- 10 based upon that value is to be paid. For purposes of determining the

- 24 (5) Base fiscal year means the first school fiscal year following

- 27 (6) Board means the school board of each school district;
- 28 (7) Categorical funds means funds limited to a specific purpose by
- 29 federal or state law, including, but not limited to, Title I funds, Title
- 30 VI funds, federal vocational education funds, federal school lunch funds,
- 31 Indian education funds, Head Start funds, and funds from the Education

- 2 (8) Consolidate means to voluntarily reduce the number of school
- 3 districts providing education to a grade group and does not include
- 4 dissolution pursuant to section 79-498;
- 5 (9) Converted contract means an expired contract that was in effect

- 7 for the education of students in a nonresident district in exchange for
- 8 tuition from the resident district when the expiration of such contract
- 9 results in the nonresident district educating students, who would have
- 10 been covered by the contract if the contract were still in effect, as

- 13 (10) Converted contract option student means a student who will be

- (b) For the final calculation of state aid pursuant to section 79-1065, the sum of average daily membership plus sixty percent of the qualified early childhood education average daily membership plus tuitioned students minus the product of the number of students enrolled in kindergarten that is not full-day kindergarten from the average daily membership multiplied by 0.5 from the school fiscal year immediately preceding the school fiscal year in which aid was paid;
- (18) Free lunch and free milk calculated students means, using the 22 most recent data available on November 1 of the school fiscal year 23 24 immediately preceding the school fiscal year in which aid is to be paid, (a) for schools that did not provide free meals to all students pursuant 25 the community eligibility provision, students who individually 26 qualified for free lunches or free milk pursuant to the federal Richard 27 28 B. Russell National School Lunch Act, 42 U.S.C. 1751 et seg., and the federal Child Nutrition Act of 1966, 42 U.S.C. 1771 et seq., as such acts 29 and sections existed on January 1, 2015, and rules and regulations 30 adopted thereunder, plus (b) for schools that provided free meals to all 31

- 1 students pursuant to the community eligibility provision, (i) for school
- 2 fiscal year 2016-17, the product of the students who attended such school
- 3 multiplied by the identified student percentage calculated pursuant to
- 4 such federal provision or (ii) for school fiscal year 2017-18 and each
- 5 school fiscal year thereafter, the greater of the number of students in
- 6 such school who individually qualified for free lunch or free milk using
- 7 the most recent school fiscal year for which the school did not provide
- 8 free meals to all students pursuant to the community eligibility
- 9 provision or one hundred ten percent of the product of the students who
- 10 qualified for free meals at such school pursuant to the community
- 11 eligibility provision multiplied by the identified student percentage
- 12 calculated pursuant to such federal provision, except that the free lunch

- 17 (19) Free lunch and free milk student means, for school fiscal years
- 18 prior to school fiscal year 2016-17, a student who qualified for free
- 19 lunches or free milk from the most recent data available on November 1 of
- 20 the school fiscal year immediately preceding the school fiscal year in
- 21 which aid is to be paid;
- 22 (20) Full-day kindergarten means kindergarten offered by a district
- 23 for at least one thousand thirty-two instructional hours;
- 24 (21) General fund budget of expenditures means the total budget of
- 25 disbursements and transfers for general fund purposes as certified in the
- 26 budget statement adopted pursuant to the Nebraska Budget Act, except that
- 27 for purposes of the limitation imposed in section 79-1023 and the
- 28 calculation pursuant to subdivision (2) of section 79-1027.01, the
- 29 general fund budget of expenditures does not include any special grant
- 30 funds, exclusive of local matching funds, received by a district;
- 31 (22) General fund expenditures means all expenditures from the

2 (23) General fund operating expenditures means for state aid calculated for school fiscal years 2012-13 and each school fiscal year 3 4 thereafter, as reported on the annual financial report for the second 5 school fiscal year immediately preceding the school fiscal year in which aid is to be paid, the total general fund expenditures minus (a) the 6 amount of all receipts to the general fund, to the extent that such 7 receipts are not included in local system formula resources, from early 8 9 childhood education tuition, summer school tuition, educational entities as defined in section 79-1201.01 for providing distance education courses 10 through the Educational Service Unit Coordinating Council to such 11 educational entities, private foundations, individuals, associations, 12 13 charitable organizations, the textbook loan program authorized by section 79-734, federal impact aid, and levy override elections pursuant to 14 section 77-3444, (b) the amount of expenditures for categorical funds, 15 tuition paid, transportation fees paid to other districts, adult 16 education, community services, redemption of the principal portion of 17 general fund debt service, retirement incentive plans authorized by 18 19 section 79-855, and staff development assistance authorized by section 79-856, (c) the amount of any transfers from the general fund to any bond 20 fund and transfers from other funds into the general fund, (d) any legal 21 expenses in excess of fifteen-hundredths of one percent of the formula 22 need for the school fiscal year in which the expenses occurred, (e)(i) 23 24 for state aid calculated for school fiscal years prior to school fiscal 25 year 2018-19, expenditures to pay for sums agreed to be paid by a school district to certificated employees in exchange for a voluntary 26 termination occurring prior to July 1, 2009, occurring on or after the 27 28 last day of the 2010-11 school year and prior to the first day of the 2013-14 school year, or, to the extent that a district has demonstrated 29 to the State Board of Education pursuant to section 79-1028.01 that the 30 agreement will result in a net savings in salary and benefit costs to the 31

- 2 (26) Income tax receipts means the amount of income tax collected
- 3 pursuant to the Nebraska Revenue Act of 1967 less all nonrefundable
- 4 credits earned and refunds made;
- 5 (27) Limited English proficiency students means the number of
- 6 students with limited English proficiency in a district from the most
- 7 recent data available on November 1 of the school fiscal year preceding
- 8 the school fiscal year in which aid is to be paid plus the difference of
- 9 such students with limited English proficiency minus the average number
- 10 of limited English proficiency students for such district, prior to such
- 11 addition, for the three immediately preceding school fiscal years if such
- 12 difference is greater than zero;
- 13 (28) Local system means a learning community for purposes of
- 14 calculation of state aid for each school fiscal year prior to school
- 15 fiscal year 2017-18, a unified system, a Class VI district and the
- 16 associated Class I districts, or a Class II, III, IV, or V district and
- 17 any affiliated Class I districts or portions of Class I districts. The
- 18 membership, expenditures, and resources of Class I districts that are
- 19 affiliated with multiple high school districts will be attributed to
- 20 local systems based on the percent of the Class I valuation that is
- 21 affiliated with each high school district;
- 22 (29) Low-income child means (a) for school fiscal years prior to
- 23 2016-17, a child under nineteen years of age living in a household having
- 24 an annual adjusted gross income for the second calendar year preceding
- 25 the beginning of the school fiscal year for which aid is being calculated
- 26 equal to or less than the maximum household income that would allow a
- 27 student from a family of four people to be a free lunch and free milk
- 28 student during the school fiscal year immediately preceding the school
- 29 fiscal year for which aid is being calculated and (b) for school fiscal
- 30 year 2016-17 and each school fiscal year thereafter, a child under
- 31 nineteen years of age living in a household having an annual adjusted

- 1 gross income for the second calendar year preceding the beginning of the
- 2 school fiscal year for which aid is being calculated equal to or less
- 3 than the maximum household income pursuant to sections 9(b)(1) and 17(c)
- 4 (4) of the Richard B. Russell National School Lunch Act, 42 U.S.C.

- 13 within the district multiplied by the ratio of the formula students in
- 14 the district divided by the total children under nineteen years of age
- 15 residing in the district as derived from income tax information;
- 16 (31) Most recently available complete data year means the most
- 17 recent single school fiscal year for which the annual financial report,
- 18 fall school district membership report, annual statistical summary,
- 19 Nebraska income tax liability by school district for the calendar year in
- 20 which the majority of the school fiscal year falls, and adjusted
- 21 valuation data are available;
- 22 (32) Poverty students means (a) for school fiscal years prior to
- 23 2016-17, the number of low-income students or the number of students who
- 24 are free lunch and free milk students in a district plus the difference
- 25 of the number of low-income students or the number of students who are
- 26 free lunch and free milk students in a district, whichever is greater,
- 27 minus the average number of poverty students for such district, prior to
- 28 such addition, for the three immediately preceding school fiscal years if
- 29 such difference is greater than zero and (b) for school fiscal year
- 30 2016-17 and each school fiscal year thereafter, the unadjusted poverty
- 31 students plus the difference of such unadjusted poverty students minus

1 the average number of poverty students for such district, prior to such

2 addition, for the three immediately preceding school fiscal years if such

3 difference is greater than zero;
