- 2 Reissue Revised Statutes of Nebraska; to change signature
- 3 requirements for nomination of partisan candidates by petition; and
- 4 to repeal the original section.
- 5 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 32-618, Reissue Revised Statutes of Nebraska, is

- 3 32-618 (1) The number of signatures of registered voters needed to
- 4 place the name of a candidate upon the nonpartisan ballot for the general
- 5 election shall be as follows:
- 6 (a) For each nonpartisan office other than members of the Board of
- 7 Regents of the University of Nebraska and board members of a Class III
- 8 school district, at least ten percent of the total number of registered
- 9 voters voting for Governor or President of the United States at the
- 10 immediately preceding general election in the district or political
- 11 subdivision in which the officer is to be elected, not to exceed two
- 12 thousand;
- 13 (b) For members of the Board of Regents of the University of
- 14 Nebraska, at least ten percent of the total number of registered voters
- 15 voting for Governor or President of the United States at the immediately
- 16 preceding general election in the regent district in which the officer is
- 17 to be elected, not to exceed one thousand; and
- 18 (c) For board members of a Class III school district, at least
- 19 twenty percent of the total number of votes cast for the board member
- 20 receiving the highest number of votes at the immediately preceding
- 21 general election in the school district.
- 22 (2) The number of signatures of registered voters needed to place
- 23 the name of a candidate for an office upon the partisan ballot for the
- 24 general election shall be as follows: at least ten percent of the
- 25 registered voters entitled to vote for the office.
- 26 <u>(a) For each partisan office to be filled by the registered voters</u>
- 27 <u>of the entire state, at least four thousand, and at least seven hundred</u>
- 28 <u>fifty signatures shall be obtained in each congressional district in the</u>
- 29 state;
- 30 (b) For each partisan office to be filled by the registered voters
- 31 of a county, at least twenty percent of the total number of registered

- 1 voters voting for Governor or President of the United States at the
- 2 <u>immediately preceding general election within the county, not to exceed</u>
- 3 two thousand, except that the number of signatures shall not be required
- 4 to exceed twenty-five percent of the total number of registered voters
- 5 voting for the office at the immediately preceding general election; and
- 6 (c) For each partisan office to be filled by the registered voters
- 7 of a political subdivision other than a county, at least twenty percent
- 8 of the total number of registered voters voting for Governor or President
- 9 of the United States at the immediately preceding general election within
- 10 the political subdivision, not to exceed two thousand.
