

AMENDMENTS TO LB300A

Introduced by Lathrop, 12.

1           1. Strike the original sections and insert the following new  
2 sections:

3           Section 1. There is hereby appropriated (1) \$39,773 from the  
4 General Fund for FY2019-20 and (2) \$81,324 from the General Fund for  
5 FY2020-21 to the Supreme Court, for Program 3, to aid in carrying out the  
6 provisions of Legislative Bill 300, One Hundred Sixth Legislature, First  
7 Session, 2019.

8           Total expenditures for permanent and temporary salaries and per  
9 diems from funds appropriated in this section shall not exceed \$37,023  
10 for FY2019-20 or \$75,156 for FY2020-21.

11          Sec. 2. There is hereby appropriated (1) \$32,482 from the General  
12 Fund for FY2019-20 and (2) \$66,439 from the General Fund for FY2020-21 to  
13 the Supreme Court, for Program 4, to aid in carrying out the provisions  
14 of Legislative Bill 300, One Hundred Sixth Legislature, First Session,  
15 2019.

16          Total expenditures for permanent and temporary salaries and per  
17 diems from funds appropriated in this section shall not exceed \$30,147  
18 for FY2019-20 or \$61,199 for FY2020-21.

19          Sec. 3. There is hereby appropriated (1) \$359,002 from the General  
20 Fund for FY2019-20 and (2) \$734,453 from the General Fund for FY2020-21  
21 to the Supreme Court, for Program 6, to aid in carrying out the  
22 provisions of Legislative Bill 300, One Hundred Sixth Legislature, First  
23 Session, 2019.

24          Total expenditures for permanent and temporary salaries and per  
25 diems from funds appropriated in this section shall not exceed \$332,677  
26 for FY2019-20 or \$675,334 for FY2020-21.

27          Sec. 4. There is hereby appropriated (1) \$298,428 from the General

1 Fund for FY2019-20 and (2) \$610,652 from the General Fund for FY2020-21  
2 to the Supreme Court, for Program 7, to aid in carrying out the  
3 provisions of Legislative Bill 300, One Hundred Sixth Legislature, First  
4 Session, 2019.

5 Total expenditures for permanent and temporary salaries and per  
6 diems from funds appropriated in this section shall not exceed \$276,085  
7 for FY2019-20 or \$560,452 for FY2020-21.

8 Sec. 5. There is hereby appropriated (1) \$36,956 from the  
9 Compensation Court Cash Fund for FY2019-20 and (2) \$75,606 from the  
10 Compensation Court Cash Fund for FY2020-21 to the Workers' Compensation  
11 Court, for Program 526, to aid in carrying out the provisions of  
12 Legislative Bill 300, One Hundred Sixth Legislature, First Session, 2019.

13 Total expenditures for permanent and temporary salaries and per  
14 diems from funds appropriated in this section shall not exceed \$34,246  
15 for FY2019-20 or \$69,520 for FY2020-21.

16 Sec. 6. This act becomes operative on July 1, 2019.

17 Sec. 7. Since an emergency exists, this act takes effect when  
18 passed and approved according to law.
