Beginning with calendar year 2024 and every three years 19 thereafter, the director shall adjust the base authority to an amount 20 equal to three percent of the actual General Fund gross receipts for the 21 most recent fiscal year for which such information is available.

22 (c) If the director requests additional authority pursuant to this 23 subsection, the executive board shall determine whether or not to approve 24 such request within forty-five calendar days after receiving the request 25 and shall notify the director of its determination. Prior to making its 26 determination, the executive board shall hold a public meeting on the 27 request and shall give seven days' public notice of such meeting. The minutes of such meeting shall show any action or inaction of the 28 29 executive board. If the executive board fails to make a determination 30 within such forty-five-day period, the request shall be deemed approved. 31 In making its determination, the executive board shall consider, among

1 other things, whether approving the request will: 2 (i) Promote economic development in line with the state's economic 3 development strategy; 4 (ii) Promote the retention and growth of high-wage, high-impact 5 businesses; (iii) Attract high-wage, high-impact businesses to the State of 6 7 Nebraska; 8 (iv) Promote investment in distressed and rural areas; and 9 (v) Result in approval of incentives for businesses which would not 10 remain, grow, or move to Nebraska but for such incentives. (d) In making its determination under this subsection, the executive 11 board may request any additional information or materials that are not 12 13 confidential or proprietary from the Department of Economic Development, 14 the Department of Revenue, or the Department of Labor.". 15 5.
