**Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.**

LB 1136 adds “a member of the board of directors of a district organized under Chapter 70” (board members for public power districts) to the definition of “Officer” in section 49-14,103.01.

LB 1136 also provides for the outright repeal of section 70-642.02 which prohibits members of the board of directors from having an interest “in any contract to which the district, or any one for its benefit, is a party, and any such director who shall have such an interest shall be subject to removal from office”.

The Accountability and Disclosure Commission estimates a cost of \$400 to revise and reprint certain materials and notify affected officials. This estimate appears to be reasonable.
