Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

This bill would change certain provisions relating to minimum sentences. It states that the minimum term shall not be less than the minimum or mandatory minimum and shall not be greater than one-third of the maximum limit. The bill also changes the minimum limit for a Class IB felony.

This bill could reduce the number of persons in prison because it has the potential to allow certain inmates to be released earlier than under current law. This could reduce prison overcrowding and save per diem costs for the Department of Correctional Services (DCS).

Reducing the prison population could reduce prison overcrowding. As of February 2020, the prison population was 156% of design capacity, or 159% if DCS inmates housed in county jails are included.

If the impact of this bill is to reduce the prison population, then this could reduce DCS per diem costs. The FY19 per diem cost for an individual inmate was \$9,408 per year, which includes DCS inmates in county jails.

In 2019, the Supreme Court estimates a minimal fiscal impact from the provisions of this bill.

In 2019, the Attorney General estimates no fiscal impact from this bill.

In 2019, the Board of Parole estimates no significant impact from this bill.

In 2019, the Department of Correctional Services states that the fiscal impact of this bill is indeterminable.

In 2019, the Commission on Public Advocacy estimates no fiscal impact from this bill.
