LB 564 would amend the provisions of the Civic and Community Center Financing Act. As amended, LB 564 would revise definitions of eligible facilities and would require that facilities subject to a grant not be sold for five years following the award of the grant. LB 564 would also allow grants to be made to municipalities for facilities jointly owned with another political subdivision, provided that the municipality ownership interest is at least 50%.

LB 565 is estimated to not impact the overall revenue received into the Civic and Community Center Financing Fund or the total spending from the fund. It is anticipated that the Department of Economic Development could use existing staff resources to revise program guidelines and application forms.
