**Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.**

This bill would change penalty, sentencing, and hearing application provisions relating to offenses against animals.

It states that if a person is convicted of either a Class IIIA felony or Class IV felony under section 28-1009 (Abandonment; cruel neglect; harassment of a police animal; penalty), then the sentencing court shall order such person not to own, possess, or reside with any animal for at least five years after the date of conviction, but such time restriction shall not exceed fifteen years.

Because this bill is not changing any penalties, it should not impact the state prison population.

The Department of Correctional Services estimates no fiscal impact from this bill.

The Supreme Court estimates a minimal fiscal impact from the provisions of this bill.
