LB859 changes requirements related to the qualifications and terms of office for the Game and Parks Commission. Changes include:

- Requiring three (3) members to actually be engaged in “farming or livestock production” instead of “agricultural pursuits”.
- Updating the requirement that a member vacate office when they cease to actually be engaged in “farming or livestock production” instead of “agricultural pursuits”.
- Provides that a member serving on the effective date of the bill may serve out the duration of their term notwithstanding the change in requirements related to bullet number one (1).

No fiscal impact is present.

The Game and Parks Commission has provided a fiscal note (see attached) also indicating no fiscal impact.

The proposed legislation changes the requirement language related to three members of the Commission. Current language states they shall be engaged in "agricultural pursuits" whereas proposed language states "farming or livestock production". No definition is provided for the new language.

The language allows for a current sitting Commissioner to fill out his/her term should they not meet the new definition requirements.

No direct fiscal impact is anticipated.
