**LEGISLATIVE BILL 300A**

FINAL READING

Introduced by Lathrop, 12.

Read first time April 25, 2019

- 1 A BILL FOR AN ACT relating to appropriations; to appropriate funds to aid
- 2 in carrying out the provisions of Legislative Bill 300, One Hundred
- 3 Sixth Legislature, First Session, 2019; to provide an operative
- 4 date; and to declare an emergency.
- 5 Be it enacted by the people of the State of Nebraska,

1           Section 1. There is hereby appropriated (1) \$39,773 from the  
2 General Fund for FY2019-20 and (2) \$81,324 from the General Fund for  
3 FY2020-21 to the Supreme Court, for Program 3, to aid in carrying out the  
4 provisions of Legislative Bill 300, One Hundred Sixth Legislature, First  
5 Session, 2019.

6           Total expenditures for permanent and temporary salaries and per  
7 diems from funds appropriated in this section shall not exceed \$37,023  
8 for FY2019-20 or \$75,156 for FY2020-21.

9           Sec. 2. There is hereby appropriated (1) \$32,482 from the General  
10 Fund for FY2019-20 and (2) \$66,439 from the General Fund for FY2020-21 to  
11 the Supreme Court, for Program 4, to aid in carrying out the provisions  
12 of Legislative Bill 300, One Hundred Sixth Legislature, First Session,  
13 2019.

14           Total expenditures for permanent and temporary salaries and per  
15 diems from funds appropriated in this section shall not exceed \$30,147  
16 for FY2019-20 or \$61,199 for FY2020-21.

17           Sec. 3. There is hereby appropriated (1) \$359,002 from the General  
18 Fund for FY2019-20 and (2) \$734,453 from the General Fund for FY2020-21  
19 to the Supreme Court, for Program 6, to aid in carrying out the  
20 provisions of Legislative Bill 300, One Hundred Sixth Legislature, First  
21 Session, 2019.

22           Total expenditures for permanent and temporary salaries and per  
23 diems from funds appropriated in this section shall not exceed \$332,677  
24 for FY2019-20 or \$675,334 for FY2020-21.

25           Sec. 4. There is hereby appropriated (1) \$298,428 from the General  
26 Fund for FY2019-20 and (2) \$610,652 from the General Fund for FY2020-21  
27 to the Supreme Court, for Program 7, to aid in carrying out the  
28 provisions of Legislative Bill 300, One Hundred Sixth Legislature, First  
29 Session, 2019.

30           Total expenditures for permanent and temporary salaries and per  
31 diems from funds appropriated in this section shall not exceed \$276,085

1 for FY2019-20 or \$560,452 for FY2020-21.

2       Sec. 5. There is hereby appropriated (1) \$36,956 from the  
3 Compensation Court Cash Fund for FY2019-20 and (2) \$75,606 from the  
4 Compensation Court Cash Fund for FY2020-21 to the Nebraska Workers'  
5 Compensation Court, for Program 526, to aid in carrying out the  
6 provisions of Legislative Bill 300, One Hundred Sixth Legislature, First  
7 Session, 2019.

8       Total expenditures for permanent and temporary salaries and per  
9 diems from funds appropriated in this section shall not exceed \$34,246  
10 for FY2019-20 or \$69,520 for FY2020-21.

11       Sec. 6. This act becomes operative on July 1, 2019.

12       Sec. 7. Since an emergency exists, this act takes effect when  
13 passed and approved according to law.
