- 1 A BILL FOR AN ACT relating to the Nebraska Milk Act; to amend sections
- 2 2-3965, 2-3966, and 2-3982, Revised Statutes Cumulative Supplement,
- 3 2018; to update federal references; to redefine a term; and to
- 4 repeal the original sections.
- 5 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 2-3965, Revised Statutes Cumulative Supplement,

- 2 2018, is amended to read:
- 3 2-3965 (1) Sections 2-3965 to 2-3992 and the publications adopted by
- 4 reference in subsections (2) and (3) of this section shall be known and
- 5 may be cited as the Nebraska Milk Act.
- 6 (2) The Legislature adopts by reference the following official
- 7 documents of the National Conference on Interstate Milk Shipments as
- 8 published by the United States Department of Health and Human Services,
- 9 United States Public Health Service/Food and Drug Administration:
- 10 (a) Grade A Pasteurized Milk Ordinance, <u>2017</u> <del>2011</del> Revision, as
- 11 delineated in subsection (3) of this section;
- 12 (b) Methods of Making Sanitation Ratings of Milk Shippers, 2017 2011
- 13 Revision;
- 14 (c) Procedures Governing the Cooperative State-Public Health
- 15 Service/Food and Drug Administration Program of the National Conference
- on Interstate Milk Shipments, 2017 2011 Revision; and
- 17 (d) Evaluation of Milk Laboratories, 2017 2011 Revision.
- 18 (3) All provisions of the Grade A Pasteurized Milk Ordinance, 2017
- 19 <del>2011</del> Revision, including footnotes relating to requirements for cottage
- 20 cheese, and the appendixes with which the ordinance requires mandatory
- 21 compliance are adopted with the following exceptions:
- 22 (a) Section 9 of the ordinance is replaced by section 2-3969;
- 23 (b) Section 15 of the ordinance is replaced by section 2-3970;
- (c) Section 16 of the ordinance is replaced by section 2-3974;
- 25 (d) Section 17 of the ordinance is not adopted;
- 26 (e) Section 3 of the ordinance, Administrative Procedures, Issuance
- 27 of Permits, is adopted with the following modifications:
- 28 (i) The department may suspend a permit for a definite period of
- 29 time or place the holder of a permit on probation upon evidence of
- 30 violation by the holder of any of the provisions of the Nebraska Milk
- 31 Act; and

- 1 (ii) Decisions of the department may be appealed and such appeals
- 2 shall be in accordance with the Administrative Procedure Act; and
- 3 (f) Section 1 of the ordinance, Definitions, is adopted except for
- 4 paragraph <u>DD</u> ₩.
- 5 (4) Copies of the Ordinance, the Appendixes, and the publications,
- 6 adopted by reference, shall be filed in the offices of the Secretary of
- 7 State, Clerk of the Legislature, and Department of Agriculture. The
- 8 copies filed with the Clerk of the Legislature shall be filed
- 9 electronically.
- 10 Sec. 2. Section 2-3966, Revised Statutes Cumulative Supplement,
- 11 2018, is amended to read:
- 12 2-3966 For purposes of the Nebraska Milk Act, unless the context
- 13 otherwise requires:
- 14 (1) 3-A Sanitary Standards <u>has the same meaning as in the Grade A</u>
- 15 Pasteurized Milk Ordinance means the standards for dairy equipment
- 16 promulgated jointly by the Sanitary Standards Subcommittee of the Dairy
- 17 Industry Committee, the Committee on Sanitary Procedure of the
- 18 International Association for Food Protection, and the Milk Safety Team,
- 19 Food and Drug Administration, Public Health Service, Center for Food
- 20 Safety and Applied Nutrition, Department of Health and Human Services in
- 21 effect on January 1, 2013;
- 22 (2) Acceptable milk means milk that qualifies under sections 2-3979
- 23 to 2-3982 as to sight and odor and that is classified acceptable for
- 24 somatic cells, bacterial content, drug residues, and sediment content;
- 25 (3) Components of milk means whey, whey and milk protein
- 26 concentrate, whey cream, cream, butter, skim milk, condensed milk, ultra-
- 27 filtered milk, milk powder, dairy blends that are at least fifty-one
- 28 percent dairy components, and any similar milk byproduct;
- 29 (4) C-I-P or cleaned-in-place means the procedure by which sanitary
- 30 pipelines or pieces of dairy equipment are mechanically cleaned in place
- 31 by circulation;

1 (5) Dairy products means products allowed to be made from milk for

- 2 manufacturing purposes and not required to be of Grade A quality;
- 3 (6) Department means the Department of Agriculture;
- 4 (7) Director means the Director of Agriculture or his or her duly
- 5 authorized agent or designee;
- 6 (8) Field representative means an individual qualified and trained
- 7 in the sanitary methods of production and handling of milk as set forth
- 8 in the Nebraska Milk Act and who is generally employed by a processing or
- 9 manufacturing milk plant or cooperative for the purpose of quality
- 10 control work;
- 11 (9) First purchaser means a person who purchases raw milk directly
- 12 from the farm for processing or for resale to a processor, who purchases
- 13 milk products or components of milk for processing or resale to a
- 14 processor, or who utilizes milk from the first purchaser's own farm for
- 15 the manufacturing of milk products or dairy products;
- 16 (10) Grade A Pasteurized Milk Ordinance means the documents
- delineated in subsection (3) of section 2-3965;
- 18 (11) Milk for manufacturing purposes means milk produced for
- 19 processing and manufacturing into products not required by law to be of
- 20 Grade A quality;
- 21 (12) Milk distributor means a person who distributes milk, fluid
- 22 milk, milk products, or dairy products whether or not the milk is shipped
- 23 within or into the state. The term does not include a milk plant, a bulk
- 24 milk hauler/sampler, or a milk producer, as such terms are defined in the
- 25 Grade A Pasteurized Milk Ordinance, or a food establishment, as defined
- 26 in the Nebraska Pure Food Act;
- 27 (13) Probational milk means milk classified undergrade for somatic
- 28 cells, bacterial content, or sediment content that may be accepted by
- 29 plants for specific time periods; and
- 30 (14) Reject milk means milk that does not qualify under sections
- 31 2-3979 to 2-3982.

1 Sec. 3. Section 2-3982, Revised Statutes Cumulative Supplement,

- 2 2018, is amended to read:
- 3 2-3982 (1) Milk for manufacturing purposes shall be classified for
- 4 sediment content, regardless of the results of the appearance and odor
- 5 examination described in section 2-3980, according to sediment standards
- 6 as follows:
- 7 (a) No. 1: Acceptable, not to exceed fifty-hundredths milligrams or
- 8 its equivalent;
- 9 (b) No. 2: Acceptable, not to exceed one and fifty-hundredths
- 10 milligrams or its equivalent;
- 11 (c) No. 3: Probational, not over ten days, not to exceed two and
- 12 fifty-hundredths milligrams or its equivalent; and
- 13 (d) No. 4: Reject, over two and fifty-hundredths milligrams or its
- 14 equivalent.
- 15 (2) Methods for determining the sediment content of the milk of
- 16 individual producers shall be the methods described in 7 C.F.R. 58.134,
- 17 as such section existed on July 1, 2018 2011.
- 18 (3) Sediment testing shall be performed at least four times every
- 19 six months at irregular intervals as designated by the director.
- 20 (4) If the sediment disc is classified as No. 1, No. 2, or No. 3,
- 21 the producer's milk may be accepted. If the sediment disc is classified
- 22 as No. 4, the milk shall be rejected. A producer's milk that is
- 23 classified as No. 3 may be accepted for a period not to exceed ten
- 24 calendar days. If at the end of ten days the producer's milk does not
- 25 meet acceptable sediment classification No. 1 or No. 2, it shall be
- 26 rejected from the market. If the sediment disc is classified as No. 4,
- 27 the milk shall be rejected and no further shipments accepted unless the
- 28 milk meets the requirements of No. 3 or better.
