- 1 A BILL FOR AN ACT relating to the Tax Equity and Educational 2 Opportunities Support Act; to amend sections 79-1022, 79-1022.02, 3 79-1023, 79-1027, and 79-1031.01, Revised Statutes Cumulative Supplement, 2018; to change the determination and certification dates relating to the distribution of aid, certification of certain 5 budget limitations as prescribed, and duties of the Appropriations 6 Committee of the Legislature; to eliminate obsolete provisions; to 7 8 harmonize provisions; to repeal the original sections; and to 9 declare an emergency.

1 Section 1. Section 79-1022, Revised Statutes Cumulative Supplement,

79-1022 (1) On or before June 10, 2019 1, 2017, and on or before 3 4 March 1 of each year thereafter, for each ensuing fiscal year, the 5 department shall determine the amounts to be distributed to each local system and each district for the ensuing school fiscal year pursuant to 6 7 the Tax Equity and Educational Opportunities Support Act and shall certify the amounts to the Director of Administrative Services, the 8 9 Auditor of Public Accounts, each learning community for school fiscal 10 years prior to school fiscal year 2017-18, and each district.
