1 Section 1. Section 25-2803, Reissue Revised Statutes of Nebraska, is

- 3 25-2803 (1) Parties in the Small Claims Court may be individuals,
- 4 partnerships, limited liability companies, corporations, unions,
- 5 associations, or any other kind of organization or entity.
- 6 (2) No party shall be represented by an attorney in the Small Claims
- 7 Court except as provided in sections 25-2804 and 25-2805.
- 8 (3) An individual shall represent himself or herself in the Small
- 9 Claims Court. A partnership shall be represented by a partner or one of
- 10 its employees. A limited liability company shall be represented by a
- 11 member, a manager, or one of its employees. A union shall be represented
- 12 by a union member or union employee. A corporation shall be represented
- 13 by one of its employees. An association shall be represented by one of
- 14 its members or by an employee of the association. Any other kind of
- 15 organization or entity shall be represented by one of its members or
- 16 employees.
- 17 (4) Only a party, natural or otherwise, who has been a party to the
- 18 transaction with the defendant for which the claim is brought may file
- 19 and prosecute a claim in the Small Claims Court.
- 20 (5) No party may file an assigned claim in the Small Claims Court.
- 21 (6) No party shall file more than two claims within any calendar
- 22 week nor more than ten claims in any calendar year in the Small Claims
- 23 Court. This subsection shall not apply to actions brought pursuant to
- 24 section 25-21,194.
- 25 (7) Notwithstanding any other provision of this section, a personal
- 26 representative of a decedent's estate, a guardian, or a conservator may
- 27 be a party in the Small Claims Court.
