- 2 60-393, 60-395, 60-396, 60-3,104, and 60-3,130.04, Revised Statutes
- 3 Supplement, 2019; to provide for Pets for Vets Plates; to create the
- 4 Pets for Vets Cash Fund; to provide powers and duties for the
- 5 Department of Veterans' Affairs; to harmonize provisions; and to
- 6 repeal the original sections.
- 7 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 60-301, Revised Statutes Supplement, 2019, is

- 4 shall be known and may be cited as the Motor Vehicle Registration Act.
- 5 Sec. 2. Section 60-393, Revised Statutes Supplement, 2019, is

- 7 60-393 Any owner who has two or more motor vehicles or trailers

- 22 60-3,224, 60-3,227, 60-3,233, 60-3,235, 60-3,238, 60-3,240, 60-3,242, and
- 23 60-3,244 and section 8 of this act. Thereafter all such motor vehicles or
- 24 trailers shall be registered on an annual basis starting in the month
- 25 chosen by the owner.

- 21 and the alternative fuel fee imposed in section 60-3,191;
- (e) Upon a trade-in or surrender of a motor vehicle under a lease;

- 24 (f) In case of a change in the situs of a motor vehicle or trailer
- 25 to a location outside of this state.
- 26 (2) If the date of the event falls within the same calendar month in
- 27 which the motor vehicle or trailer is acquired, no refund shall be
- 28 allowed for such month.
- 29 (3) If the transferor or lessee acquires another motor vehicle at
- 30 the time of the transfer, trade-in, or surrender, the transferor or
- 31 lessee shall have the credit provided for in this section applied toward

- 1 payment of the motor vehicle fees and taxes then owing. Otherwise, the
- 2 transferor or lessee shall file a claim for refund with the county
- 3 treasurer upon an application form prescribed by the department.
- 4 (4) The registered owner or lessee shall make a claim for refund or
- 5 credit of the fees and taxes for the unexpired months in the registration
- 6 period within sixty days after the date of the event or shall be deemed
- 7 to have forfeited his or her right to such refund or credit.
- 8 (5) For purposes of this section, the date of the event shall be:
- 9 (a) In the case of a transfer or loss, the date of the transfer or loss;
- 10 (b) in the case of a change in the situs, the date of registration in
- 11 another state; (c) in the case of a trade-in or surrender under a lease,
- 12 the date of trade-in or surrender; (d) in the case of a legislative act,
- 13 the effective date of the act; and (e) in the case of a court decision,
- 14 the date the decision is rendered.
- 15 (6) Application for registration or for reassignment of license
- 16 plates and, when appropriate, validation decals to another motor vehicle
- 17 or trailer shall be made within thirty days of the date of purchase.
- 18 (7) If a motor vehicle or trailer was reported stolen under section
- 19 60-178, a refund under this section shall not be reduced for a lost plate
- 20 charge and a credit under this section may be reduced for a lost plate
- 21 charge but the applicant shall not be required to pay the plate fee for

- 23 (8) The county treasurer shall refund the motor vehicle fee and
- 24 registration fee from the fees which have not been transferred to the
- 25 State Treasurer. The county treasurer shall make payment to the claimant
- 26 from the undistributed motor vehicle taxes of the taxing unit where the
- 27 tax money was originally distributed. No refund of less than two dollars

When no such 19 replacement motor vehicle, trailer, or semitrailer is so registered, the 20 county treasurer shall forward the application and affidavit, if any, to 21 the State Treasurer who shall determine the amount, if any, of the 22 allowable credit for the registration fee and issue a credit certificate 23 24 to the owner. For the motor vehicle tax and fee, the county treasurer shall determine the amount, if any, of the allowable credit and issue a 25 credit certificate to the owner. When such motor vehicle, trailer, or 26 semitrailer is removed from service within the same month in which it was 27 28 registered, no credits shall be allowed for such month. The credits may be applied against taxes and fees for new or replacement motor vehicles, 29 trailers, or semitrailers incurred within one year after cancellation of 30 registration of the motor vehicle, trailer, or semitrailer for which the 31

- 4 department shall inspect the plate or plates and may approve the plate or

- 21 Sec. 8. (1) Beginning January 1, 2021, a person may apply to the
- 22 department for Pets for Vets Plates in lieu of regular license plates on
- 23 an application prescribed and provided by the department for any motor
- 24 <u>vehicle</u>, trailer, or semitrailer, except for a motor vehicle, trailer, or
- 25 semitrailer registered under section 60-3,198. An applicant receiving a
- 26 Pets for Vets Plate for a farm truck with a gross weight of over sixteen
- 27 tons or for a commercial motor vehicle registered for a gross weight of
- 28 five tons or over shall affix the appropriate tonnage decal to the plate.
- 29 The department shall make forms available for such applications through
- 30 the county treasurers. The license plates shall be issued upon payment of
- 31 the license fee described in subsection (2) of this section.

- 1 (2)(a) In addition to all other fees required for registration under
- 2 the Motor Vehicle Registration Act, each application for initial issuance
- 3 or renewal of alphanumeric Pets for Vets Plates shall be accompanied by a
- 4 fee of five dollars. County treasurers collecting fees pursuant to this
- 5 subdivision shall remit such fees to the State Treasurer. The State
- 6 Treasurer shall credit five dollars of the fee to the Pets for Vets Cash
- 7 Fund.
- 8 (b) In addition to all other fees required for registration under
- 9 the Motor Vehicle Registration Act, each application for initial issuance
- 10 or renewal of personalized message Pets for Vets Plates shall be
- 11 <u>accompanied by a fee of forty dollars. County treasurers collecting fees</u>
- 12 pursuant to this subdivision shall remit such fees to the State
- 13 Treasurer. The State Treasurer shall credit twenty-five percent of the
- 14 fee for initial issuance and renewal of such plates to the Department of
- 15 Motor Vehicles Cash Fund and seventy-five percent of the fee to the Pets
- 16 for Vets Cash Fund.
- 17 (3) When the department receives an application for Pets for Vets
- 18 Plates, the department may deliver the plates and registration
- 19 certificate to the applicant by United States mail or to the county
- 20 treasurer of the county in which the motor vehicle, trailer, or
- 21 <u>semitrailer</u> is registered and the delivery of the plates and registration
- 22 certificate shall be made through a secure process and system. The county
- 23 treasurer or the department shall issue Pets for Vets Plates in lieu of
- 24 regular license plates when the applicant complies with the other
- 25 provisions of the Motor Vehicle Registration Act for registration of the
- 26 motor vehicle, trailer, or semitrailer. If Pets for Vets Plates are lost,
- 27 stolen, or mutilated, the licensee shall be issued replacement license
- 28 plates upon request pursuant to section 60-3,157.
- 29 <u>(4) The county treasurer or the department may issue temporary</u>
- 30 license stickers to the applicant under this section for the applicant to
- 31 lawfully operate the vehicle pending receipt of the license plates. No

- 1 charge in addition to the registration fee shall be made for the issuance
- 2 of a temporary license sticker under this subsection. The department
- 3 shall furnish temporary license stickers for issuance by the county
- 4 treasurer at no cost to the counties. The department may adopt and
- 5 promulgate rules and regulations regarding the design and issuance of
- 6 temporary license stickers.
- 7 <u>(5) The owner of a motor vehicle, trailer, or semitrailer bearing</u>
- 8 Pets for Vets Plates may apply to the county treasurer to have such
- 9 plates transferred to a motor vehicle, trailer, or semitrailer other than
- 10 the motor vehicle, trailer, or semitrailer for which such plates were
- 11 originally purchased if such motor vehicle, trailer, or semitrailer is
- 12 owned by the owner of the plates. The owner may have the unused portion
- 13 of the fee for the plates credited to the other motor vehicle, trailer,
- or semitrailer that will bear the plates at the rate of eight and one-
- 15 third percent per month for each full month left in the registration
- 16 period. Application for such transfer shall be accompanied by a fee of
- 17 three dollars. Fees collected pursuant to this subsection shall be
- 18 remitted to the State Treasurer for credit to the Department of Motor
- 19 Vehicles Cash Fund.
- 20 (6) If the cost of manufacturing Pets for Vets Plates at any time
- 21 exceeds the amount charged for license plates pursuant to section
- 22 60-3,102, any money to be credited to the Pets for Vets Cash Fund shall
- 23 instead be credited first to the Highway Trust Fund in an amount equal to
- 24 the difference between the manufacturing costs of Pets for Vets Plates
- 25 and the amount charged pursuant to section 60-3,102 with respect to such
- 26 plates and the remainder shall be credited to the Pets for Vets Cash
- 27 Fund.
- Sec. 9. The Department of Veterans' Affairs shall create a program
- 29 for the purpose of providing financial support to veterans for the costs
- 30 associated with adopting a pet animal. The department shall use the funds
- 31 collected under section 8 of this act to award grants to carry out the

- 1 purposes of such program. The department may administer the program or
- 2 <u>contract with an organization dedicated to the care of dogs and cats to</u>
- 3 <u>administer the program.</u>
- 4 Sec. 10. The Pets for Vets Cash Fund is created for the purpose of
- 5 <u>administering the veteran grant program created under section 9 of this</u>
- 6 act. Any funds collected pursuant to section 8 of this act shall be
- 7 remitted to the State Treasurer for credit to such fund. The state
- 8 investment officer shall invest any money in the fund available for
- 9 investment pursuant to the Nebraska Capital Expansion Act and the
- 10 Nebraska State Funds Investment Act.
- 11 Sec. 11. Original sections 60-301, 60-393, 60-395, 60-396,
- 12 60-3,104, and 60-3,130.04, Revised Statutes Supplement, 2019, are
- 13 repealed.
