- 1 A BILL FOR AN ACT relating to the Nebraska Liquor Control Act; to amend
- 2 section 53-101, Revised Statutes Cumulative Supplement, 2018; to
- 3 provide for transportation and temporary off-site storage of
- 4 alcoholic liquor by retail licensees for customer pickup as
- 5 prescribed; to define terms; to harmonize provisions; and to repeal
- 6 the original section.
- 7 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 53-101, Revised Statutes Cumulative Supplement,

- 2 2018, is amended to read:
- 3 53-101 Sections 53-101 to 53-1,122 and section 2 of this act shall
- 4 be known and may be cited as the Nebraska Liquor Control Act.
- 5 Sec. 2. (1) A retail licensee may transport alcoholic liquor from
- 6 the licensed premises of the licensee to the licensed premises of a
- 7 second retail licensee under common ownership with the first retail
- 8 licensee for temporary storage and pickup by the customer if:
- 9 (a) The alcoholic liquor is for a customer-prepaid, online order of
- 10 alcoholic liquor from the first retail licensee; and
- 11 (b) Such transportation and storage is for the sole purpose of
- 12 <u>customer pickup.</u>
- 13 (2) Customer pickup under this section shall only be allowed between
- 14 the hours of 7:00 a.m. and 9:00 p.m.
- 15 (3) Alcoholic liquor transported under this section shall not be
- 16 stored at a pickup location for more than twenty-four hours after
- 17 delivery to the pickup location. If the prepaid customer refuses, fails,
- 18 or is ineligible to take possession of the alcoholic liquor within such
- 19 twenty-four-hour period, such alcoholic liquor shall be returned to the
- 20 <u>first retail licensee</u>.
- 21 (4) Alcoholic liquor transported and stored under this section shall
- 22 not be commingled with other alcoholic liquor at the pickup location.
- 23 (5) When engaged in activities authorized under this section, the
- 24 second retail licensee and employees of such licensee at the pickup
- 25 location shall be deemed agents of the first licensee for purposes of the
- 26 Nebraska Liquor Control Act.
- 27 (6) A retail licensee shall not use the authority provided in this
- 28 <u>section to engage in wholesaling or distribution of liquor or otherwise</u>
- 29 evade the requirements or prohibitions of the Nebraska Liquor Control
- 30 <u>Act.</u>
- 31 (7) For purposes of this section:

1 (a) Common ownership means the same person or persons own eighty

- 2 percent or more of each retail licensee; and
- 3 (b) Pickup location means the licensed premises of the second retail
- 4 <u>licensee.</u>
- 5 (8) The commission may adopt and promulgate rules and regulations as
- 6 <u>necessary to carry out this section.</u>
