## **LEGISLATIVE BILL 25**

2	sections 38-151 and 71-8701, Reissue Revised Statutes of Nebraska;
3	to provide additional fees for certain credentials; to provide for a
4	termination date; to create a fund; to harmonize provisions; to
5	provide an operative date; and to repeal the original sections.

6 Be it enacted by the people of the State of Nebraska,

Section 1. Section 38-151, Reissue Revised Statutes of Nebraska, is
amended to read:

3 38-151 (1) It is the intent of the Legislature that the revenue to 4 cover the cost of the credentialing system administered by the department is to be derived from General Funds, cash funds, federal funds, gifts, 5 grants, or fees from individuals or businesses seeking credentials. The 6 7 credentialing system includes the totality of the credentialing infrastructure and the process of issuance and renewal of credentials, 8 9 examinations, inspections, investigations, continuing competency, 10 compliance assurance, the periodic review under section 38-128, and the activities conducted under the Nebraska Regulation of Health Professions 11 Act, for individuals and businesses that provide health services, health-12 related services, and environmental services. 13

14 (2) The department shall determine the cost of the credentialing 15 system for such individuals and businesses by calculating the total of 16 the base costs, the variable costs, and any adjustments as provided in 17 sections 38-152 to 38-154.

(3) When fees are to be established pursuant to section 38-155 for 18 individuals or businesses other than individuals in the practice of 19 constructing or decommissioning water wells and installing water well 20 pumps and pumping equipment, the department, with the recommendation of 21 the appropriate board if applicable, shall base the fees on the cost of 22 the credentialing system and shall include usual and customary cost 23 24 increases, a reasonable reserve, and the cost of any new or additional 25 credentialing activities. For individuals in the practice of constructing or decommissioning water wells and installing water well pumps and 26 pumping equipment, the Water Well Standards and Contractors' Licensing 27 Board shall establish the fees as otherwise provided in this subsection. 28 All such fees shall be used as provided in section 38-157. 29

30 <u>(4) In addition to the fees established under section 38-155, each</u> 31 applicant for the initial issuance and renewal of a credential to

1	practice as a physician or an osteopathic physician under the Medicine
2	and Surgery Practice Act shall pay a patient safety fee of fifty dollars
3	and to practice as a physician assistant under the Medicine and Surgery
4	Practice Act shall pay a patient safety fee of twenty dollars, which fee
5	shall be collected biennially with the initial or renewal fee for the
6	credential. Revenue from such fee shall be remitted to the State
7	Treasurer for credit to the Patient Safety Cash Fund. The patient safety
8	fee shall terminate on January 1, 2026, unless extended by the
9	<u>Legislature.</u>
10	Sec. 2. Section 71-8701, Reissue Revised Statutes of Nebraska, is
11	amended to read:
12	71-8701 Sections 71-8701 to 71-8721 <u>and section 3 of this act</u> shall
13	be known and may be cited as the Patient Safety Improvement Act.
14	Sec. 3. The Patient Safety Cash Fund is created. The Patient Safety
15	Cash Fund shall only be used to support the activities of a patient
16	safety organization. Any money in the fund available for investment shall
17	<u>be invested by the state investment officer pursuant to the Nebraska</u>
18	Capital Expansion Act and the Nebraska State Funds Investment Act.
19	Sec. 4. This act becomes operative on January 1, 2020.
20	Sec. 5. Original sections 38-151 and 71-8701, Reissue Revised
21	Statutes of Nebraska, are repealed.
